Education Must be in Depth

It has been ten years since the establishment of Adream, but that's not the point.

The point is that we are running a holistic educational public welfare project on the largest scale in present China, even in the whole world in one-fifth counties in China.

There have always been difficulties and challenges through the past year, ten years, and every year. The challenges for the efficiency of public welfare and the field of education never stop. But this is not the point either.

The point is that our original aspiration has never changed as time passed.

There are 2973 Adream Centers running on the vast expanse of China, which has led 140,000 teachers to pave the educational road for 32 million children, helping them grow in confidence and dignity. How excellent my Adream is!

Thank you for the support, as we have stood at the most front end of education and public welfare all the time, hearing directly from this generation. Thank you to our friends, we have run with love and passed the torch burning with the flame of benevolence from generation to generation, with the purpose of achieving fruitful dreams for children in China

In 2017, we have in total raised RMB 153,000,000 yuan and built 417 new Adream Centers. The children have finished 590,000 Adream Courses in 2973 Adream Centers in China. Adream has continuously passed the International ISO9001:2015 Certification and SGS Global NGO Criteria, successfully ranking among top 5% NGO organizations which have top level of governance and management in the world.

We are still ranked top 1 on the list of transparent organizations. Transparency is in our DNA—one of the most significant parts of our foundation. Constantly becoming more efficient and allowing extreme transparency helps us win the trust of our donators.

Last year, our colleagues visited and interviewed 1046 schools to discuss and share the Adream Center Project. We, together with the Bureau of Education, have allocated RMB 26,130,000 to our project. We have established a Adream Learning Community and entered classes in remote areas with incredible educators from Shanghai. Eventually, the test and evaluation of Adream Curriculum (version 2.0) could prove the value of competency-based education. The competency, which can be quantized, has proved that education doesn't just change our living environment, but also our thought processes.

Nowadays, facing the fast development of online education, the waves of studying abroad chosen by more and more students in China, and the disastrous outcomes of current educational changes, as the thinker and leader of Education Public Welfare set for Millennials in China, Adream has given its answer: We will continue developing the competency-based education and promoting a balanced development of education, encouraging education to promote social progress.

From helping students "be educated" to "being well-educated" to "study and test well", with the needs of basic education changing, our public welfare modal has also innovated all the time. Now ten years have passed, and we have started digging deep.

According to the report last year, we have established Shanghai Adream Public Welfare Development Center and Learning Community Research Institution. To deep plough, we will spare no efforts in innovating our organization and fulfilling our vision while meeting high standards.

To deep plough, we hope that education remains a tradition of intensive cultivation, even in our highly-informed generation with a national economy.

Education is the greatest demand for people yearning for a better life. Each of our Adream staff members who are responsible for the balanced development of quality education feels how great a responsibility they are shouldering.

With integrity, we build on our mission to stimulate individual creativity, with attention to both education and public welfare.

We hope that every teacher influences children and community during their lifetime, as we as establish a learning community, allowing the next generation to evolve and see their future.

The old world was what we once called the Clock Cosmos, where nothing could be changed; what is arriving in a moment is the Chaotic Universe, where nothing can be predicted. In that chaotic future world, Adream will still tenderly stick to its original intention, storing energy for our nation and finding solutions for the whole world. In the uncertain future, Adream will show its definition. We will steadily give abiding love to those who are forgotten in the process of fast development, to last one of those who are in remote mountain areas or at the back of civilization and happiness.

Last year, I came back to where dreams started again—Barkam, a small town in Aba Prefecture of Sichuan Province. I met the little girl named Luhua again. She had red cheeks and was as well behaved as other children in Tibetan area. The difference between them is that Luhua would invite me to her home, holding my hand gently. She will also imagine somewhere beyond the edge of the sky with me in Adream Center in school.



In 2017, Adream's donations came from four fundraising platforms: Government funding, corporate and leadership donations, foundation fundraising, and public fundraising, which all showed strong momentum and good balance. The donation amount for "Share with Love" hit a record high. The amount of online donations has increased consistently for four years. Meanwhile, we increased the exploration efforts on donating innovation and launched the first equitable charitably trust in China. We have also helped donors to become the participators and advocators by creating a model of communication and allowing input and suggestions.

In 2017, Adream finished the upgrade to the 6.0 version Adream Center on classroom design and connotation. We did research on dream power theory, set up assessment system for Adream Curriculum and finished the third-party evaluation on the newest two courses (Going Far Away and Love and Dream). In 2017, we also built the learning community institute. Based on last ten year's works on Competency-based Education, we will continue carry out a research based revolution on the structure of education.

In 2017, Adream is cooperating with other with charitable programs via special funds, united fundraising and the "Huodui Charity" online donating platform. We set up 16 special funds in total with our cooperators and recruited 2,400,000 people to support our organization.

For achievement on internal management in 2017, Adream built total quality management system and passed ISO-9001:2015. We were the first charitable foundation who passed this certification in China. We also passed the Switzerland SGS global NGO criteria and ranked among world's NGO which had leading management level. We were also the first charitable organization in China to win "Ramcharan Management Practices Award" as excellence award. HR department improved the training development system for new staffs and middle managers. Compared with last year, the turnover rate decreased from 27% to 22%.

Adream retained our high standard of social responsibility and hailed as "China' s Most Transparent Charitable Foundation" by Jiemian News in 2017.

For the aspect of Co-promotion of education and Charitable development, Adream cooperated with Aon Hewitt and published "2016 Aon Hewitt Annual Report of Charitable Organization's Compensation and Benefits survey", became the rotating presidency of 2018 China Foundation Forum, as well as the first charitable organization to undertake Annual Conference micro forum of The Chinese Society of Education.

Therefore, the investment returns in 2017 were relatively high.

Other revenues which mainly included bank interests, commission charges and foreign exchange losses were RMB79,500 in total. Because the total amount of them was relatively low, the year-on-year ratio was relatively high.

Until the end of 2017, Adream had set up 16 special funds in total. 13 among them produced cost in 2017. The total amount of special funds in 2016 was 6, therefore, the reason for the relatively increase of special funds expenses was the increase of the amount of special funds.

Other limited expenses mainly included RMB 17.87 million for 99 Charity Day program, RMB 1.506 million for MIS system, RMB 6.201 million for the "Huodui" program, RMB 2.735 million for Adream Caravan, RMB 672,000 for "Looking Into the future" institute and RMB 4.258 million for material donations. Because the increase of expenses on promoting the development of charity (99 Charity Day program and "Huodui" program), the annual other limited expenses had a substantial increase.

Operating capital ratio is calculated as: end-of-year net asset balance divided by annual total expenditures. This indicates the number of years the foundation can sustain operations without external donations. According to international conventions, a radio of 1 or higher indicates a stable and healthy financial state.

Per capita efficiency of full-time employees is calculated as: the annual total expenditures divided by the number of full-time employees at year-end, which includes 59 full-time employees of the foundation and 27 full-time employees of charitable development center.

Administrative Expenses Summary

In 2017, administrative expenses totaled approximately RMB 585 million, 5.16% of total expenditures. The administrative expenses in 2017 was almost the same as last year.

Administrative Expenses donations and unlimited donations had long been the bottleneck for fundraising. To support Adream's long-term sustainable development, we put forward new 6.0 version Adream Center that cost RMB 200,000 and five-year operational services fees with 5% of administrative expenses included.

2017 Fundraising Report Fundraising Overview

In 2017, Adream received donation and service income totalled RMB 141,446,587.68, increased 49% of compared the same time last year. Donor satisfaction survey indicated the mark of donor's satisfaction had raised from 80.25 in 2016 to 86.25 in 2017.

Donations in 2017 came from the following sources: Donations from government – 20%. Donations from private funds – 59%. Donations from public offering funds – 21%. Donations from private funds still be the very significant way for Adream. Besides, we were constantly making efforts on public offering fields. Donation from public sources in 2017 had a rapidly growth compared with 2016.

For the character of donors, individual and group donations -33%; donations from private enterprises -30%; contributions from education bureaus and government-20%; donations from allocated funds -17%. The structure of Adream's fundraising still to be robust multivariate.







The Analysis of Fundraising and Reflection

Donations in 2017 came from the following sources: Donations from government branches -20%. Donations from private funds -59%. Donations from public offering funds -21%. Donations from private funds are still a financial significant resource for Adream. However, we were constantly making efforts to acquire more funds in the public domain. Donation from public sources in 2017 has rapidly grown in comparison to 2016. Meanwhile, we have started to explore new modes of fundraising, which will promote the implementation of a long-term strategy in a flexible way.

1. Breakthrough has been made in public fundraising. During the 99 Public Welfare Day, Adream has gained great support from many benevolent enterprises such as BreadTalk, Honglicun, League of Legends, etc. We stimulated public enthusiasm towards donation with the help of enterprises. Besides, we have combined public welfare with scenes of life and closely contacted to the masses, which has made public welfare become our daily life. Through the activity No Dream No Childhood, stars and entrepreneurs like Chen Shu, Liu Tao, Ren Quan, Fu sheng, etc. have participated in and shared their dreams during childhood, aimed at appealing the public to pay more attention to competency-based education. During the three days, we together with 102 projects have totally gained support from 280,000 people. In 2017, we've gained support from 2,400,000 donators through platforms such as Tencent Charity, Ant Financial Charity, etc.

2. In 2017, Adream has emphatically proposed the strategy called Donators in Adream, which means we will design and offer opportunities to donators to enter the project site in Adream Center, participating in public welfare activities by themselves and exchanging energy through the two-way interaction between donators and beneficiaries. Furthermore, after a long period of accumulation and hard work, the lasting eight-years Sharing Love Banquet has collected amount of fundraising hitting record highs in 2017, which has made it the high-quality fundraising activities belonging to Adream together with donators. In 2017, the donators who have donated to Adream for more than two years account for 54% of total donators. Their donations to the charity fund account for 62% of the total amount. We will continue improving our service for donors, making more friends become who will accompany us through the journey of promoting competency-based education.

3. In 2017, cooperating with government and education bureau in 69 districts and counties all over China, Adream has built Adream Centers by allocating capital. We have raised RMB 26,137,450 as our allocated capital, and the sum has increased by 16.55% year on year. The large-scale covered areas whose total amount was over RMB one million include Qidong in Jiangsu Province, Jiangyan District in Taizhou in Jiangsu Province, Baoji in Shaanxi Province, Erqi District in Zhengzhou in Henan Province and Yongfeng District in Ji'an in Jilin Province. After ten years, the public welfare service system of competency-based education has obtained approval from many local governments and education bureaus. With further specialization of cooperation, further enhance of depth of cooperation and steady increasing of allocated capitals, the Adream Center has become one of the best cooperative choices for local education bureau to develop competency-based education.

4. Adream set 9 new special charitable funds in 2017, the total amount of special charitable funds that both have set up and started operating has grown to 16. These special funds have fundraised CNY 15,897,171.44. Adream built Adream+ club together with the founders of special funds. "Gathered to advocate competency-based education, design charitable products, expand fundraising network, and build brand influence". Promoting specialized funds is one of the best methods to partner with for enterprises and individuals who want to consistently participate in charitable activities.

5. Start to innovate with fundraising. Cooperating with SDIC Taikang Trust Co., Ltd., Adream put up with the first and the only Equity Charitable Trust in China in 2017, to investigate how to use finance + charity to support fundraising. Furthermore, we have also have considered the possibilities for a return on equity rights, Charitable Trust, Artworks Charitable Trust, Single charity trustees. We Believe we will have more innovative solutions in 2018.

However, Adream still has two obstacles: First, non-limiting administrative cost donations only occupied 1% on the total fundraising in 2017, which is not good for foundation's long-time development and to support the growth of innovation. Secondly, the government-owned distribution of Adream Center program had a rapid growth, while the gift matching donations did not have rapid growth.

Adream Center Program

Adream Center classrooms are the core product for Adream's competency-based education system. In 2017, we were committed to iterative evolution and upgrade on the design of Adream Center as well as the Adream Center operation system. In 2017, Adream released reports on the development of Adream Centers and spent more time on the curriculum investigation, teacher training and operational services to constantly empower more teachers and children.

Adream Center Construction

Adream Center is a specialized classroom that carries Adream's concepts about competency-based education, as well as the significant method to transform traditional teaching concepts. We believe the specialized space can improve human relationships. With elaborately designed color patterns, functional area, and the aid of multimedia equipment, the Adream Centers are aimed to provide a place for children to learn in a group, think independently and work cooperatively. They can also learn through fun, creative activities and cultivate character traits in Adream Centers. In 2017, we built 417 new Adream Center in total, vvand the total amount of Adream Centers grew to 2973.

On April 2017 of Adream's annual conference, Adream published the 6.0 edition Adream Center created with Woods Bagot, containing three design concepts, children oriented, environment friendly, strong interaction and nine environmental indexes. On June 2017, the first 6.0 edition Adream center was completed on the Malcolm No.2 Middle Schoo, where we built the first center ten years ago. In 2017, we built 97 6.0 edition Adream Centers, and in 2018, we will completely shift to the new model.



Operation Services of Adream Center

In 2017, there were 2,180 Adream Centers operating within the service period, operating on 600 districts, counties, flags and cities. The operation services Adream provided includes the regular 1-star teacher training, 2-star teacher training, school visits and class evaluation. The Adream staff visited 1046 schools in 2017 and helped to improve the operational standards of Adream Centers to promote competency-based education. According to data from Adream Box postings, the number teachers who started using Adream Curriculum in 2017 climbed to 24619, and 590,000 class sessions using our curriculum.

As the number of Adream Centers has increased, the requirements for local operations is also higher. In 2017, management organizations for Adream must be suitable for the local environment as the platform of teachers steadily increases. Adream salon increased from 155 to 213 and incorporated 1256 schools, boasting an annual growth up to 36.2%. In 2017, Adream salon not only took over a huge number works for Adream Curriculum operations and researches, but also showcased many of Adream's local activities. In 2018, following the "Deep Driving" Strategy, we will focus on the construction and development of Adream salon, trying to build online education support systems for local schools.

Cooperating with the Merchants Charitable Foundation, Adream opened the 4th "Going the Distance" travel competition in 2017. 1886 students and 121 teachers from 88 schools, 148 classes joined this activity. We finally chose 30 teams from 16 provinces such as Fujian, Guangdong, Guizhou, Qinghai, Shandong, Yunnan which consisted of 165 students to go to 17 cities to accomplish their travel plans. These team are accompanied by 55 volunteers from the Merchant's Charity Foundation. That summer vacation, we witnessed those children chasing their dreams. They made the



whole travel plans, created budgets for themselves, and witnessed their own independence and growth.


To build the platform for the communication of Adream Teacher, promote their professional abilities, show and expend excellent Adream Curriculum cases, communicate Adream Curriculum teaching methods, and strengthen relationships with partners, Adream held the 2nd "Adream Class" . 400 leaders from Bureau of Education in each districts and counties as well as principals from Adream Center schools witnessed 40 brilliant teachers showcase their classes. On April 2018, Adream invited these teachers who went to Singapore for study tour during the finals. Participants enjoyed the ambience, learned the culture, and communicated with local education colleagues.

Curriculum Research and Development


2017 was the year for Adream to promote the Adream Curriculum "from existing to becoming excellent". Adream Curriculum's 1.0 Self-Selection System has built to be a "multi-choice supermarket" for competency-based education. Based on Adream's aim to create "high quality curriculum packs" for competency-based education, the 2.0 Core System is on the procedure. Meanwhile, the Research of 3.0 Special System and higher standard curriculum has accomplished the plan. Adream Curriculum system is planning to upgrade iteration.

In 2017, we finished the total research and development on "Going the Distance" and "Love and Dream". Besides, "International Comprehension" and "Career Life" is about on-line. Meanwhile, we started to do the evaluation on the quality of curriculum. We evaluated our students on two parts, general culture (based on the concepts of to become dream chaser who pursues truth and love) and curriculum development (based on goals of the curriculums), to provide clear data to analyze the actual benefit of Adream Curriculum and helped to build a model to evaluate student's competency-based educational abilities. The following are the comparison charts for "Love and Dream" and "Going the Distance".

Under the background of competency-based education system, the logic




Comparison Chart on Competency-based Abilities for "Going the Distance"




about curriculum-constructed, which has been based onthe research of competency-based education, has become a kind of international consensus. As for the main power researching and developing Adream Curriculum, we always keep pace with the times. In 2017, Adream Curriculum Institute has cooperated with Professor Cui Yunkuo, who has been the director of Curriculum and Teaching Research institute in East China Normal University, and also with many eminent experts and scholars. We focused on the educational philosophy of Adream and finally finished the research of Theory of Adream's Power. Besides, we further simplified the purpose of education. The system and connotation of core competency of Adream's Power has begun to emerge.

Meanwhile, Adream has explored the method of expanding Adream Curriculum that is based on online platform and the mode for Adream Teachers to continue learning and developing. We have provided books such as Learning About Adream Curriculum and Technology and Skills of Evaluating Adream Curriculum, online communication about object lessons, teaching guidance for the raters of national competition lessons. Besides, dozens of Wechat lesson groups have continuously held professional discussion and tried more types such as reading lectures, lessons discussion, experience sharing, and so on. The highest lesson-on-demand is 1700 times, covering over ten thousands of teachers.

Teacher Development

Adream created new lecturer training courses to empower Adream teachers in 2017. Through training and practice, 174 Adream teachers became Adream verified lecturers. The verified Adream lecturers would use our curriculum in classrooms, lead training platforms all over the country, and encourage Competency-based Education

Based on three external courses, the teacher training in 2017 also instilled Positive Discipline, leadership through training courses and holistic reading. This quality curriculum gives more choices for the development of our teachers and supports them to grow with full-scale development.

Adream trained 13639 teachers in 2017 and organized a total of 56 teacher training camps except for the Adream Coach Plan.

Online Operations

Adream continually to improve the online service system. Before 2018, the total amount of Adream Box users had risen to 61,967. In 2017, there are 13,080 new users. Active users total 7,500, a huge increase from 1500. Users now post around 83,000 articles, as only 32,000 were posted the previous year. In 2017, Adream made further development on its IT system, Supported Adream Box users to access Adream centers with their mobile devices, and supported Adream the use of technology in classrooms. Adream Box still need to be improved on the user activation and user stickiness. To display this progress, we are working on designing more products and services to better support Adream teacher's daily educational work.

Community-based Adream Center

As the extended base for Adream to advocate Children Competency-based Education, Community-based Adream Centers provide a series of curriculums and activities based on "Holistic education" for children in local communities on family weekends and summer vacations. At the end of 2017, Adream had built 16 Community-based Adream Centers throughout the country, which included cities and provinces such as Shanghai, Shenzhen, Zhejiang, Chengdu, Tianjin, Hainan. In 2017, we completed 1400 sessions of Adream curriculum, served over 20,000 children and families, educated more than 300 community-based Adream Lecturers, and evaluated around 10 social organizations. The Community-based Adream Center gained support from central financers in 2017.

The Community-based program built the cooperation model for enterprises, local governments, foundations, social organizations, volunteers to share with benefits and create the educational environment of society altogether. By providing Competency-based Education service, we aided children and families, improved relationships in the community, and spurred community residents and social volunteers to join community activities.

In 2018, Community-based Adream Centers will further expand their learning platforms to be offered throughout the whole country. Based on the guidance of Competency-based Education, making efforts to build children education, parent classes and family activities, to further promote the development of community development.









Adream Caravan

Adream established the "Adream Caravan" Program in 2015. "Adream Caravan" is a portable Adream Center, which offers multiple classroom resources such as multi-media video teaching, micro library, a portable reading room, and cinema. The Adream Caravan would stop in a town for 2 to 3 days, allowing the local children to experience several of the Adream Curriculum classes. These advanced, multi-oriented learning experiences, would bring new concepts about Competency-based education to local people.

In 2017, the Suning Adream Caravan travelled for 200 days, during which they traversed 8 provinces, made 17 stops and covered 25,000 kilometers in Anhui, Hunan, Hubei, Fujian, Jiangxi, Hubei, Sichuan, and Gansu. They reached over 20 local governments and education monitored departments, 1800 principals and teachers. 3500 volunteers took part in the activities and 10 interactive sharing courses were led by celebrities. Children enjoyed 28 sessions of VR experimental classes, 30 sessions of photography classes, 17 sessions of 3D printing classes, 150 sessions of Adream Curriculums. Over 10,000 children came into close contact with Suning Adream Caravan's Adream Curriculums.

"Looking into the Future" Education Institute

Adream held a "Looking into the Future" forum in 2016 and oversaw the establishment of Looking into the Future Education Institute. As an independent institution team which based on local environment and think globally, 2017 is the trial year for Looking

into the Future Education Institute to improve and make progress on this forum. This team is still in the startup period, and has much room to improve.

Until the end of 2017, "Looking into the Future" Educational Institute has reached 2000 school principals, directors of education and donors via 19 electronic weekly newspapers, 3 bimonthly publications, and 50 Wechat and headline articles. We must inform educational workers of the need to broaden the horizon of Competency-based Education and embrace the unknown changes in this constantly changeable era for a better future.



Adream's Cooperative Programs

Special Funds

In 2017, cooperating with Anta, Mary Kay, Putao technology and Ms. Aling GONG, Adream established 4 new special funds, bringing the total number of officially established special funds to 6, and the total amount of funds raised reached 15,897,171.44 RMB. These special funds focus primarily on competency-based education, teacher training, charitable innovation people training, and directly benefitted over 200,000 children. Adream had shaped the deep cooperation with enterprises and individuals to investigate competency-based education.

Among them, Adream published the first "The Competencybased Education Investigation Report of Middle School Female Students" with Mary Kay Good Future Special Fund. The female competency-based Curriculums was distributed to 8 provinces and 15 schools, and over 2500 female students from middle schools benefited. Adream -One Window Special Charitable Fund collected unused iPad in the city, and built over 30 village iPad classrooms in over 8 provinces, to develop remote Dual-Oualified Teaching and STEAM courses, to open the windows towards the future for over 3000 children in village. Adream-Putao Technology special fund built 25 classrooms equipped with technology, offering computer programming classes for students from kindergartens and primary schools. Over 6,000 children obtained the ability to embrace the new Al era. Adream - Youth Soccer Special Charitable Fund's "soccer dream planning" which including soccer packages, soccer courses and training camp covered 6 provinces, 11 counties, cities and districts and 82 schools, around 100,000 children allow children

to play soccer with professional guidance and security. Adream-Anta "Grow up Healthy" Special Fund donated 750,000 RMB, the value of donated materials was up to 2,850,000 RMB. Developed sports competency-based curriculum and built a Adream Center on Changting, Fujian. Adream- Gansu's Education Special Fund entirely constructed a 6.0 edition Adream Center in Gansu Province and also built a 5.0 edition Adream Center with the money raised. Adream -Haolin Ye Teacher Training used funds from Impoverished County Special Charitable Fund to train 60 teachers in Lianhua poor county, Jiangxi province. Adream-Yiwu Union financial interests Special Fund incubated 2 charitable groups and undertook 10 cooperative studies of other charitable organizations to support a training system for local Yiwu charitable organizations. Adream - Sesame Credit Special Charitable Fund cooperated with 22 universities. brought the "unmanned station" out to the universities and into the street to do 1-day flash mob, and helped to create credit for the society. Adream- SEED Special Fund held innovative seed class which lasted 2 weeks at Harvard University. 29 innovative seed youth people joined and favorable ratings reached 93%. United Fundraising

In 2017, under Tencent's "99 Charity Day" platform, Adream launched a public fundraising initiative with 102 education charitable partners with 7 main types, competency-based education, help children go to school, reading, teaching materials, summer camp, training, and special education. Adream held three offline workshops in Shanghai, Chengdu and Shenzhen, shared experiences with Program management, financing management and public offering to empower our partners. Meanwhile, the Adream system worked with partners to create efficient ways to collaborate on activities. Adream raised 12,090,000 RMB through online platforms with their partners this year.




Huodui Charity

In 2017, the Huodui Charity raised 8,089,924.74 RMB. In 2017, the number of donors Huodui received did not rise as steadily as in 2016. However, the average donation amount rose significantly. Meanwhile, Huodui Charity continued to expand the "Compassion Pool" service. By matching donations, we encouraged public participation and broadened the influence of every donation. Before the end of the 2017, the number of partners that worked with the Huodui Charity Compassion Pool had climbed to 20.

In 2017, the Huodui Charity actively developed new service models, including "donate with action", which required used both offline and internet platforms, and collaborated with block-chain technology point donation with Zhong' an Technology and utilized data mining analysis methods with Shanghai Jiao Tong University Institute of Public Welfare. We also planned big events such as "Huodui Music Festival", "Adream Assembly", "Welfare Workshop" and "Match man", cumulative exposure of over 5 million people in major channels.

In 2018, Huodui Charity will still make efforts to improve standardized processes, enhance data security, establish a tiered service system and work on branding initiatives.













2017 Service InnovationLearning Community Institute

The "School as a Learning Community" theory originates from J. Dewey's education ideology. Based on democratic values, public service and excellence, action begins with teachers to ensure every child has the right to quality learning. It also wants to ensure that every teacher in the school has the right to trust, listen and learn from each other, to provide parents have the right to intervene in schools. This concept has been practiced over 28 countries and districts worldwide.

With Adream's continual research, we found that the competency-based education we pursued is not only a curriculum or a tool. It relates to the revolution of the whole structure of education. For instance, the relationship between school and society, children's education and their future lives, the class model learning model and the function of school as it relates to each teacher.

In 2017, with the support of Professor Qiquan ZHONG, Adream Foundation cooperated with teams of Dr. Jingjing CHEN to establish the "Learning Community Institute". By publishing monographs, offering local training, joint lesson studies, national pilot teacher workshops and national learning community education summits, this institute constantly promotes class revolution, development of students and teachers and the transforms schools from 18 provinces and cities.

Parent-Child Charitable Summer Camp

To deepen a donor's charitable experience and improve client relationships, Adream started running a parent-child charitable summer camp in 2017. United by family with charity as the central theme, this experimental summer camp integrated finding, investigation, fusion and growth. In the form of parent-child participation, parents and children can both experience the Adream Curriculum's competency-based education.

Based on several years' experience with "CICC parent-child charitable summer camp", Adream cooperated with donors to organize many charitable summer camps, including the Adream Ten Year-Malcom charitable summer camp, Anta employee charitable summer camp, Guotai Asset charitable summer camp, Beijing Hong Kong Jockey Club charitable summer camp and CKGSB charitable summer camp. These summer camps received fantastic reviews from our donors and families, deepening their experience working with charities

In 2018, we will continue to customize the summer camp to the donors' wishes. We will also persist in researching out competency-based educational curriculums, running our learning camp, trying to create diverse learning experiences, and allowing more donors to become participants of our programs.

Internal Support System

Human Resource

As of the end of 2017, Adream maintained 86 full-time staff members (including 59 Foundation staffs and 27 Charity Development Center staffs). With a total of 105 employees (including the short-term volunteers and consultants). Employees with a college degree make up 2%, those with a bachelor degree 71%, and those with a master degree around 27%. 12 people have overseas study background, 26% have previously held management positions, and the per capita efficiency value for our full-time employees is RMB 1.34 million. In 2017, we are more focused on our employee's health, self-growth and career development. The turnover rate is 22%, which decreased 5% when compared to 27%

Management skills are crucial for employees in any organization. In 2017, Adream organized the first Reserve Talent Training Camp, to help young manage group open their minds and learn and improve their leadership abilities. We also designed a comprehensive training and emersion plan for new employees. Adream advocates "Learning and sharing" in the human resources sector. We use different methods to strengthen internal communication and help our employees develop.



Internal Management

In 2017, thanks to the efforts of our staffs, Adream foundation achieved ISO9001:2015 certification and became the first nongovernmental organization that passed SGS global NGO criteria stanards in China with flying colors. Third-party certifications evaluated us from different management dimensions, such as strategy, compliance, communication and brand, human resource, fundraising, financing, program designing, program implementation, monitoring and evaluation, and yearly improvements. This certificate was highly motivating to our internal management. However, they are not our end goal for professional management. Instead, they are the start for us to constantly improve and promote our management system. Adream will insist on evaluations that are transparent and efficient, aiming to be a model in the charity field.

To support the requirement of our management system in becoming transparent and efficient, Adream made the following modifications for their IT system in 2017:

- 1. Improved the process and monitoring of internal management
- 2. Submitted the first phase of BI system, finished the summarization, analysis and report display of the core data.
- 3. Built new mobile functions, including Adream Center search engine, CRM integration, business records, report search etc.

4. Finished developing the core system and training programs.

However, the existing products still mainly relies on computer programs and most of the functions are still not available on portable devices. which makes difficult for users to have those experiences. Meanwhile, IDs stored in different systems are still independent, meaning the data cannot be integrated, and some core functions are not suited for real service needs. Therefore, in 2018, we will to improve and perfect our IT products.





2017 Report of Board of Supervisors

The second Board held four conferences in 2017. All members attended the abovementioned meetings.

The Board held their annual meeting in April of 2017. They reviewed and adopted the "Board Report" in the 2016 Annual Report, and discussed in depth the possible impact of the implementation of the Charity Act on the duties of supervisors.

According to the Articles of Association of the Foundation, the Board oversees the Foundation's annual operations and management in the previous years. The 2017 report is as follows:

- 1. On January 17, 2017, the Tenth Conference of the Second Board nominated Ms. Yu SHEN as the Second board member and the Secretary-general of Adream
- 2. The re-appointment of the honorary directors, the vice chairman of the committees in 2017 complied with laws and

- 3. A procedure for the change registration address of Adream Foundation was undergone, and the board also added Jin HE and Yu SHEN as board members in legitimate and
- 4. In 2017, the Foundation submitted the 2016 annual audit report, annual report to the Shanghai Municipal Civil Affairs Bureau and Shanghai Administration Bureau of NGOs. After passing the annual inspection, the annual report was published on the Foundation's
- 5. In April of 2017, Adream held three press conferences for the annual report, and sent out the Foundation's monthly report to competent authorities, donors, partners, volunteers who regularly disclosed the quarterly reports on the website.

Significant Litigation and Arbitration

On September 30, 2015, the foundation commissioned Shanghai Yi Wen Logistics Co., Ltd. to pack and transport a porcelain eight trigrams tripod donated by the famous Ru porcelain master. Zhu Wenli. The carrier was entrusted to buy insurance for the porcelain from Chinese People's Property Insurance Co., Ltd. Shanghai Branch. The insured amount was 200,000 yuan. During the transportation process, the porcelain sustained serious damage. Despite repeated negotiations, the insurance company was only willing to bear 10,000 yuan of the repair costs, and was unwilling to compensate us. On May 31, 2016, the Foundation entrusted Shanghai United Law Firm to bring a lawsuit to the Huangpu District People's Court of Shanghai, against Shanghai People's Property Insurance Co., Ltd. Shanghai Branch on the related property insurance contract dispute. On September 29, 2017, this case concluded. The Huangpu District People's Court of Shanghai rules that Chinese People's Property Insurance Co., Ltd. Shanghai Branch must compensate Adream Foundation 117,562.50

Suggestions on Management Risk


The Board of Supervisors reminds management of the following risks:

The strength of our risk defense and recovery is weak, so the non-limiting donation need to be further improved.
- 2. Adream Foundation's brand awareness is still weak when applied to public fields. We hope to strengthen investment in the field of public communication in the future, to improve the public awareness and reputation, and actively increase the proportion of public donations.

2018 Strategy Summary

2017 is the tenth year Adream has worked on Competency-based Education, as well as a key year to build on the past and look into the future for our 2020 Strategy. In 2017, based on the theme "Empowerment through looking into the future", Adream invested more energy into curriculum development, teacher training, school and community active degree improvements, and beneficiary services.

In 2018, we will start from the heart, driving deep into the heart of education, promoting programs, charitable organizations and this field's sustainable development:

- 1. The amount of newly built Adream Centers is between 400 to 450. The centers are distributed in areas where poverty is rampant, where we can find suitable locations with the cooperation of local governments, poverty relief organizations and donors. The Adream Center operation strategy would connect to local people to empower them, inviting "new hometown sage" who live outside of their hometowns but care about local education development. We also will invite local teachers and volunteers who are enthusiastic about education. We work together on the local operation of Adream Center, to improve the operational efficiency of Adream Center and the quality of education in local areas.
- 2. In 2018, we will finish all the development of a 2.0 Adream curriculum system for Adream Center and 1.0 Adream curriculum system for Community-based Adream Centers; Finish the

framework of "Adream Power" theory and start to investigate Adream teaching methods; upgrade "Adream Teacher" competency-based models and use an index to judge the growth of students. In the Learning Community, incorporating the Adream Curriculum into classes with efficiency will improve the whole development of schools. Partnering with different organizations and people, we will promote the organic development of schools, communities and educational environments in local areas.

- 3. Detailed internal development mechanism, build knowledge management system and built IT system available for mobile platforms. Pay attention on employee development, stress professionalism in charitable services.
- 4. With the help of technology and the internet, we will expand our core competency-based education to the public and investigate tiny competency-based education product to reach more people. Let more people to pay attention, experience and join in advocating education charitable things.
- 5. Continue to investment in the internal system, further improve the standard for charitable operation. We will uphold high standards for social responsibility, while also actively joining and promoting the development of charity. We will use Education to promote the improvement of society, and push for our organization's ability to influence society.

Ten Questions to AdreamWhy We Choose Education?

The unbalance of the society and the back of these problems are highly related to the education. The development of society is promoted by the upgrade of people's cognitions. The upgrade of people's cognitions could be accomplished by learning, and education is the main type for people to learn knowledge. Therefore, to promote the development of society could be accomplished by improving education. The mission of Adream is to develop competency-based education, promote education equality, and drive social process through education.

The competency-based education which Adream advocates for is derived from Holistic Education and the Constructivism Learning Theory, influenced by the concept of traditional Chinese culture and education.

Instead of changing learner's abilities, competency-based education aims to giving chances for learners to connect with the real society and unknown fields, providing possibilities for them to make investigations with situations, and help them to become "Dream Chaser who pursue truth and love".

What Main Points of Education We Aim to Solve?

Many people criticize the Chinese education for "teaching without cultivating". We think "the acquisition of common knowledge combined with a highly competitive learning atmosphere and the absence of individual curiosity personal development" is conducted by teaching towards the college examination.

What Do We Do?

Ten years ago, Adream started to try to face the pain points of examination-oriented education. We built the "Adream Center", which is the prototype of competency-based charitable products integrated with hardware and software to support the classroom.

The original thought was quite pure, establishing a school library for students just like "Chengpin" did. This library could be the most beautiful classroom in this school, could be the place for children to make dreams, could be the place that widen student's horizon which still in the compulsory education period. We hope we can help those children who are also limited by other things. Through books and online resources, we can help them to look to the outside and see this fantastic world, exciting them to learn and enjoy school.

We designed, constructed and operated the Adream Center with our imagination of future classrooms:

First, the content we would learn in the Adream should be interdisciplinary and integrated.

Second, the method to learn knowledge should mainly be theme





learning and project learning.

Thirdly, the environment for learning should be exploratory. Children are encouraged to help each other and work in team.

Fourthly, the teacher should be supportive and encouraging.

From 1.0 edition to 6.0 edition, the Adream Center always has been a children-centered place that gives them rights and power.

By following 30 Adream Curriculums in the centers, the children's heart and horizon are being continuously expanded to become a dream chaser who pursues love and truth.

Truth Seeking: Learning with independent g and experimental thinking, sincere and upright character, and a strong and rational brain

Pursuing Love: Cognition and Connection. Feel love, believe in love and deliver love, being warm-hearted.

Chasing Dream: Dare to dream, always hold be innocent and curious like a child.



What is "Adream Curriculum"?

The competency-based Education is education that helps children consider the future. It is instilled in a school classroom. The content of it is Adream Curriculum has 30 modules and supports for students from grade 1 to grade 9. It does not encourage students to memorize and routinely regurgitate information. It includes learning with themes, investigating problems, team working and presentations. The content to learn includes:

Who we are—Encourage children to learn themselves

Where we to go— Inspire children's imagination

How we go—The method and techniques followed to achieve dreams

We encourage teachers to establish an Adream course per week for children via Adream Center. We hope this can open children's heart and horizon, to become a "dream chaser who pursues love and truth". Every curriculum starts with children's curiosity. No matter where they are and no matter good or bad on their grades, they still have chance to achieve their dreams.

Three concepts in the Adream Curriculum: Questions > Answers , Methods > Knowledge , Trust > Help.

Adream Centers now exist all over the country, and 300 million classes have been taught using Adream Curriculums. In these class, children can write stories based on their hometown specialties and perform their own plays. They are encouraged to explain their beliefs by conducting speeches and debates, or trying to persuade others towards one action plan. Sometimes, classes would even be conducted outside. Teachers would bring on nature walks and use stethoscope to listen a tree's heartbeat. Children would also learn about financial decision making in the Adream center, using lessons that demonstrate differentiated market competition strategies and win-win negotiation methods.

We also have a 3-minute video on our financing course to demonstrate the effects of Adream courses.



How Did We Build These 2973 Adream Centers?

Charitable organization always admire programs that are small but have a great sphere of influence. Before Adream began, only one product named "Hope Project" was well-known in the education charity field. The management model was managed separately by Youth Development Foundation, but had the same goal.

After studying the business model of chain stores, we designed the standard Adream Center construction model, which can be easily replicated. This is the first iteration of our product. This iteration allowed us to upgrade the configuration of Adream Center every year or two. Nowadays, Adream Center has upgraded to a 6.0 edition model. Because of the standard construction process, four staff members could work together to build 400 Adream Centers within one year.

How to Operate Our Adream "Chain Stores"?

This our bottleneck that funnels into the core product in the Adream Center—Adream Curriculum.

We have designed more than 30 kinds of competency-based education curriculums suitable for children from grades 1 to 9. These curriculums have made their way into everyday school curriculums and become a part of everyday school life.

We train the manager of the chain store—the president of this school, while also training the staff—teachers. To achieve this, we established multilevel teacher training and learning systems. From 1-star Teacher Training Camp to our Principal's Leadership F Plan to Director's Workshop, Adream helps educate workers find chances to learn inside and outside of the class, to discover the meaning of education and to be children's Adream Guide under the pressure of examination

Finally, we build an online community for teachers—the Adream Box, which supports more than 60,000 verified teachers who can share ideas online.

What Is Our Charitable Education Concept?


Just like education, charity does not just relate to one individual. Everyone must be concerned and involved. We have experienced these following changes during our ten years in the charity field:

Charity 1.0—Provided material and monetary donations, helped poor children with paying for school fees.

Charity 2.0— Provided training for teachers, helped children to obtain quality education.

Charity 3.0-- Cross-border empowerment, help children obtain deeper learning.

We have shared the cooperation model with 184 counties in all over the country. We have received donations from enterprises, individuals and governments which sum up to 570,000,000 RMB, and provide sustainable competency-based education services for 3,200,000 children in this country.



What Are the Differences between Traditional Charities and Modern Public Service?

Charity is personal activity; public service is public activity;

The core of charity is to give, the core of public service is to join;

The aim of charity is to aid, the aim of public service is to empower;

Charity is a redistribution of wealth based on an individual's moral compass, public service is a societal revolution for the public's benefit:

Charity is conducted by an individual, public service is a group effort

Therefore, public service has obvious benefits:

- 1) Achieve public goals: not for the good of a company or an individual/family:
- 2) Public ownership: management is not done by a company or an individual/family;
- 3) Public mobilization: communicate and fundraise on a public platform, encouraging them to join us;
- 4) Value orientation for accepting public accountability: transparency to the public eve:
- 5) Promote public discussion: aim to solve crucial societal issues.

How Do We Use Business Concepts to Do Public Service?

When we first entered the charity field in 2007, we claimed that we would bring "business concepts and models to the charitable field". Business experience helped us solve the resource allocation problem of having limited resource faced with unlimited needs. How do we to solve the problem of having limited donations to meet unlimited needs from people who need help? Adream started to brainstorm strategies for resource allocation. The main issue we found is the gap between the content children learned and requirements of the future. To solve this competency-based education problem, we came up with the Adream Centers, which offer hardware in terms of the physical space and 5-year long curriculum and teacher training service systems.

To build Adream Centers, we need quality control. We copy the chain model of McDonald's and Starbucks. We continuously decompress every step and come up with standard procedures, asking schools to supervise the construction. This standard constructive process allows for the standardization of each step, including remote designing, purchasing, logistics and construction installation.

To build the chain store, we need an operational management system. Every Adream Center is the "Knowledge Chain Store" of Adream. The most significant manager for the classroom is theteacher. Therefore, we build multilevel training systems for educational workers. We also build offline communities for our teachers, to glue the Adream Center operation system together. We integrate information from each separate school to aggregate the cluster effect of chain stores.

We developed a system relating to project risk management and project evaluation. The indexes relate to many subjects, such as the risk management of a chosen point, the choice and evaluation of suppliers, the evaluation of our curriculum, the operation and supervision of projects, and effect evaluation. For example, during the evaluation and selection of schools, this system will imitate credit card issuance review mechanisms. The evaluation consists of written assessments, telephone interviews and field investigation to do cross reviews. Finally, the committee will choose whether this school pass the selection. We hope schools would not just simply received donations, but make continuous efforts to help solve the problem of inferior education in their local provinces.

In 2017, Adream achieved ISO9001 (2015 edition) certification and became the first non-governmental organization to pass this certification in China. Adream also passed SGS global NGO criteria and become part of the top 5% NGOs with the best national management standards.

How Can We Achieve Transparency?

In 2009, Adream Foundation wrote their annual report for the first time. Just like other charitable organizations did, we reported our results under the motto: "do the right thing, tell the sad stories". This method of reporting donation public donation amounts and activities, is the simplest public transparency 1.0.

The annual report of 2010 includes not only discloses data and reports, but also reflects on our work. We disclose the information of foundation in a structured way. If we made any mistakes, they will be openly disclosed in our reports. Besides, regulators also require us to disclose our balance sheet, Statement of Operating Activities and Cash Flow Statement to demonstrate the assets of our foundation and our systems of operation. However, Adream Foundation is one of the few foundations who are willing to disclose financial notes: affiliated transactions, income from investments, details of income from large donations, details of projects activities expenses, management expenses, and salaries of council members, supervisors, and employees.

Transparency 2.0 tells a systematic and transparent story, just like transparency 1.0. However, the transparency 3.0 follows the motto "reflection in the public eye, keep the process transparent".

The Adream annual report includes detailed analysis. We analyze how we fundraised each year. We also discuss the reason for the growth in fundraising, which methods would be sustainable and which were not as valuable. Through analyzing, we could grow our company. Meanwhile, we let our donors and colleagues understand why Adream grows so rapidly. Besides the fundraising analysis, we also think about the operation of the organization and invite independent third-party professional organization to do program effect evaluations. Only if we face the problem head on can we get sustainable development.

Adream's goal is to become an organization that completely caters the public by being transparent. This is not only reflected on our website and in our annual reports, but if also highlighted in working details from our Adream partners. We cannot obtain transparency in our results without including transparency in our process. Qualified transparency not only requires courage, but it necessary for all organizations who need public funds.

Adream Foundation is committed to changing Chinese education, developing competency-based education and promote the balance of education. We welcome everyone to participate and empower Chinese education while building sustainable public service platforms.


Appendix Feedback of Beneficiaries

Adream Foundation Spring Course Experimental Assessment and Analysis Report in 2017

In recent ten years, Adream Foundation has trained more than 70,000 dream teachers in nearly 3,000 dream center teaching spaces, reaching nearly 3 million middle school students and pupils in many cities.

In our new development stage, the feedback from executors and Beneficiaries of Adream Foundation curriculum is good. But we also need quantized data and scientific methods to track our progress. From the curriculum research and development angle, we must examine if the present curriculum is beneficial. After we implement it, we must measure how students and teachers can improve and grow. While comparing experimental curriculum groups with control groups, we must see if the changes can be measured and be statistically significant. Besides the test scores, we should see if they have changed in attitudes, conditions and concepts.

To try and tackle these issues, Adream curriculum research institute along with Beijing Work Development center of Yide Society, choose 2 courses from 9 core courses in dream curriculum phase 2.0—Going the Distance and Love and Dream to measure the effects of these experimental courses in Spring semester, 2017.



How Do We Carry out the Assessment?

1. Constructing A Means of Assessment

The goal of assessing the dream curriculum is to understand feedback and learn from suggestions of teachers and students. In the process of assessment, our main job is to build two core measure scale. One scale is to measure the changes in student course accomplishments and another is used to measure the changes in student comprehensive accomplishment abilities.

2. Statistical Analysis Method

For our evaluation of two curriculums, we cannot discriminate between objects because of a lack of resources. Therefore, in this research, we use a statistic method supported by semi-experimental research.

3. Designate Assessment Scale

In this assessment, there were 30 Adream Curriculum teachers interviewed from the Going the Distance curriculum, representing 11 cities in 10 provinces and 64% of the total number of teachers. This evaluation covered all the provinces which had Adream Curriculum Going the Distance and all of the cities except for Dingxi City in Gansu Province.

In the student survey, students in the Course (experimental) Group were selected from 25 classes and 11 cities. The students in the Comparison (control) Group were from 5 classes of 4 cities. To control for the effects

of performing quantitative research, we ran focus group for students from Shanxi Yuncheng, Sichuan Guangyuan, Jiangsu, Changzhou, Jilin Changbaishan and Fujian Wuyishan. Each school chose 2 groups of students from the same grade and each group had 6 students. The groups were divided depending on whether they attend the curriculum Going to the Distance or not. This study also kept their gender, character and academic performance at a controlled average level.

For the Love and Dream curriculum study, we chose 9 different provinces, cities and autonomous regions from 42 classes who used the curriculum in their classes. 13 teachers who taught Love and Dream from 10 different cities did telephone interview or face-to-face interviews. For the school interview, we sampled in a geographically diverse manner, choosing from Liaoning Shenyang in Northeastern China and Henan Zhengzhou in the middle of China to do focus group interviews. We interviewed two groups for each school (Experimental Group and Control Group were both included) which contained 12 students in total to understand their true feelings on this curriculum. We also received 355 surveys from students in 11 classes who experienced this curriculum. This was compared to 177 surveys from students in 5 classes who were in the control group and hadn't experience the curriculum.

4. Scale validation tool

Our core scale validation tool totally developed by our own research group. Therefore, we need to measure the reliability, stability and validity of the scale validation tool. After passing two tests of reliability and validity, we could ensure these two scale validation tools could be the basic tools for this test as they obtained scientific verification abilities.

Current Assessment Findings:

1. Intuitive Satisfaction

1.1 Going the Distance

Teachers believe the support for schools and students are great ;

90 percent of students interviews that: they themselves, their classmates, their parents and their teachers show a supportive attitude to going the distance.

1.2 Love and Dream

From the teachers interviewed, more than 80 percent of the students they taught, other colleagues, school leaders and parents also support this course.

More than 90 percent of students believe :students always show a more positive attitude when they have the feedback of their parents. When parents pay more attention, they score higher on evaluations. Furthermore, students want more picture books and courses materials to be provided in the classroom.

2. Special Experience and Achievement

2.1 Going the Distance

Teachers' perspectives

Teachers consider :the courses students abilities of independence and self-learning. Open-ended and teamwork tasks also encourage multiple different kinds of interaction patterns for students. Personally, they feel that this curriculum helps them to grow with the children, and expands their horizons to advance in their learning about new concepts.

Students' perspectives:

Going the Distance give plenty of opportunities for students to describe their thoughts, and encourages them to share opinions. This curriculum requires practice and investigation, which is an ideal type of curriculum. What's more, teachers who use this curriculum have a very different teaching style than their regular teachers.

$2.2 \ \mathsf{Love} \ \mathsf{and} \ \mathsf{Dream} \ \mathsf{Curriculum}$

Teachers' perspectives:

Love and Dream helps teachers gain more opportunities to get touch with new ideas and other teachers from all over China. By learning new teacher methods, not only teach for the sake of helping kids succeed on the test, but also hold interdisciplinary, innovative class sessions. They want to bring these useful elements from the Adream Curriculum to their other classes, and to students who have not experienced this teaching style.

Students' perspectives:

We made conclusions using key words that students mentioned in their surveys about their feeling towards this curriculum, and got the following word cloud. According to the key words shown in this figure, we could make direct analysis that they feel this curriculum is very fun. This curriculum has many different fresh elements. Surprisingly, primary students from grade 1 and 2 could even use words such as "investigation" or "new knowledge" to describe what they had acquired.




3. Curriculum Competency-based Ability

3.1 Going the Distance Curriculum

While we examined the data from Going the Distance, we made the following observations: The Experimental Group sharply improved on the skill module. The Experimental Group also greatly improved in the areas of team work and asking for help. However, the Experimental Group showed poor performance on measures such as public rules and showing respect to other cultures in an unfamiliar area. Because the age of Experimental Group is lower than the Control Group, we can assume their travel experiences are also fewer than those of the control group. During travel, experiences with other cultures would bring changes to their behaviors and attitudes.

Comparison Chart on Course Competency-based Abilities for "Going the Distance"




When comparing competency-based abilities, we find that the differences between experimental and control groups are very distinct, the students in experimental groups perform better thanthose in control

groups in 9 abilities which we are investigating. The significant themes are thinking independently, making rational choices, use different tools, living in the environment, and living with others under pressure.

In focal groups, we made some more vivid observations and discoveries: the students of experimental group make statement actively and can think independently universally. They are not following blindly. However, the students in control groups are more passive when faced with open-ended questions. They prefer short, standardized questions to long, individualized ones.

3.2 Love and Dream Curriculum

When measuring the effect of the Love and Dream curriculum, we asked 9 different direction questions around the curriculum theme of "reading and understanding", from interest, expression, listening, presentation and so on to demonstrate how the teaching with picture books can affect students from the experimental groups. We found that students from the experimental Love and Dream group perform statistically significantly better than students in control groups.

On a scale test of competency-based abilities, the students of experimental groups perform better than the students in comparison group on 9 competency-based tasks, and their differences on 7 tests are statistic significantly higher. The most prominent abilities are using multiple-tools, living with environment, thinking independently, making rational choices, self-cognition, using evidence under pressure and live with others.

From these two courses, we can realize that when we control all variables, the students who have taken dream courses score higher than their counterparts who have not taken the course. The statistically significant results demonstrate the value of dream curriculum from data level.

Future Assessment and Expectation

The assessment of Adream Foundation is only exploratory. It's impossible to find and solve all the issues, assessments should be conducted periodically to become a "planned jigsaws" and become a indispensable part of the whole project.

According to the curriculum design and the life cycle of operation, assessments of Adream curriculum should be divided into corresponding processes to promote constructive evaluation. The greatest advantage of this kind of division is each slight improvement can apply to project operation directly instead of taking this assessment as a disposable end.

I. Audit Opinion

We have audited the attached financial statements of Adream Foundation (hereinafter referred to as "foundation"), including the balance sheet for December 31, 2017 and declaration of operating activities and notes for financial statements of 2017.

We believe that the financial statements of foundation are prepared according to the accounting procedure of Non-governmental Non-profit Organizations. Reflecting the financial situation of foundation on December 31, 2017 in all significant aspects and operating outcomes of 2017.


In the process of conducting audit works according to auditing standards, we use professional adjustment and maintain professional doubt. Meanwhile, we also conduct the works as follow:

Adream Foundation Notes to Financial Statements December 31st, 2017

1. Basic Information of Company

Adream Foundation (hereinafter referred to as "the foundation") is a non-profit foundation founded on August 14, 2008 with the approval document numbered Hu Min Zhi Fa [2008] No. 11 and obtained Shanghai Basic Certificate No. 0087 Foundation Legal Person Registration Certificate, foundation organization code certificate 50178073-8. The original fund is 2 million Yuan, legal representative is Pan Jiangxue.

The foundation was reviewed and approved at the Second Council Meeting of the Second Session of Council of the Foundation. The nature of the foundation was changed from local private raising foundation to local public fundraising foundation, for which Beijing Property and Credit Group served as the capital contributor and invested additional RMB 2 million into the original fund. The Civil Affairs Bureau and the Shanghai municipal social organization administration issued the Humin Social Development No. 0042 to grant a change of registration in 2014. On January 26, 2014, the company obtained the Shanghai Foundation Certificate No. 0087 Foundation Legal Person Registration Certificate.

On November 7, 2016, the foundation renewed and collected Registration Certificate of Legal Entity of Foundation, for which the unified social credit code is 53310000501780738C and period of validity is from March 22, 2016 to June 7, 2018.

The foundation serves as a public raising foundation and its business scope covers: providing help and support to the poor; providing assistance in improvement of educational facilities; providing financial support to quality and competence- oriented education and promoting employment.

II. Basis for Preparation of Financial Statements

The foundation prepares financial statements according to Requirements of Accounting System of Non-governmental Non-profit Organization.

III. Description of Important Accounting Politics and Accounting Estimates

(I) Accounting Period

An accounting year refers to the period from January I to December 3 I based on the Gregorian calendar.

(II) Base Currency for Bookkeeping

RMB is adopted by the foundation as the base currency for bookkeeping.

(III) Bookkeeping Basis & Principle of Valuation

The accrual basis of accounting is adopted by the foundation as its bookkeeping basis. When measuring accounting elements, the foundation generally adopts historical cost. As for any circumstance in which replacement cost, act realizable value, present value or other nature is used for measurement based on Accounting System of Non- governmental Non-profit Organization, the foundation will provide special description.

(IV) Criteria for Recognition of Cash & Cash Equivalent

When cash flow statement is prepared, cash on hand and deposits that can be used for payment should be recognized as cash. Investments which meet four conditions including short period (generally becoming due within three months since date of purchase), high liquidity, easy conversion to a known amount of cash and very low risk of value change should be recognized as cash equivalents.

(V) Foreign Currency Transactions

As for economic transactions involving foreign currency, the foundation should conduct bookkeeping based on the amount of RMB converted from foreign currency according to market exchange rate (middle rate) published by the People's Bank of China. All foreign currency assets and liabilities should be adjusted at the end of the period based on the market middle rate of RMB published by the People's Bank of China. Difference of exchange relevant to assets meeting conditions of capitalization should be capitalized and added to value of relevant assets.

(VI) Recognition of Donated Assets

Cash assets donated to the foundation should be recorded based on the received amount. As for non-cash assets donated to the foundation, such as short-term investments, supplies, long-term investments, fixed or other assets, bookkeeping values should be determined using the following method.

- 1. If the donor provides relevant documents (such as invoice, customs declarations, relevant agreements, etc.), the amount indicated on these documents should be used as the value for book-keeping. In case of a relatively big difference between the amount indicated a document and the appraised value of any donated asset, fair appraisal of the cost of this donation should be recorded as the bookkeeping value.
- 2. If the donor does not provide any relevant documents, donated asset should be recorded based on their appraised values.

(VII) Receivables

Receivables refer to the various receivables that have been received by the foundation during its daily business activities, and are recorded in accordance with the actual amount incurred. At the end of the period, the recoverability of the receivables shall be analyzed, and the bad debt losses expected to be incurred shall be accrued for bad debts according to the individual recognition method, and the bad debt losses shall be recognized and included in the current expenses.

Criteria for bad debt loss:

In the case of bankruptcy or death of a debtor, those receivables that can't be recovered by his/her bankruptcy assets or heritage should be recognized as bad debt loss.

In the case of a debtor failing to fulfill his/her obligation to pay a debt, those receivables that cannot be recovered after three years or will not be recovered based on evidence should be recognized as bad debt loss.

According to the administration authority of the foundation, bad debts can be recognized as loss on bad debts based on approval of the council, for which the funds drawn from bad debt reserves should be written off.

Accounting method for bad debts: The allowance method should be adopted as the accounting method for bad debts.

(VIII) Inventory

1. Categorization of Inventory

Inventory refers to finished products or goods held by the foundation in daily activities for sale or production materials, supplies or goods for sale or donation, or to be consumed in production, supply of service or daily management.

Inventory includes: material in transit, goods in stock, etc.

2. Inventory Valuation Method

When a product is obtained, the initial measurement should be conducted based on costs, including purchase cost, processing cost and other costs. When inventory is delivered from a warehouse, evaluation should be conducted based on the moving weighted average inventory cost method

3. Inventory System

The perpetual inventory system should be adopted.

4.Basis for Determination of Net Realizable Value of Inventory Method for Calculation and Drawing of Inventory Falling Price Reserves

The foundation determines inventory value at the end of a cash accounting period based on

the smallest different between the net realizable value and book value. When the net realizable value is less than the book value, inventory falling price reserves should be drawn based on such difference. If the net realizable value rebounds, such rebounded amount should be reversed in the recognized amount of loss from falling price.

(IX) Short-term Investments

Short-term investments refer to investments that can be liquidated at any time and held for no longer than one year.

- 1. While being obtained, short-term investments should be measured based on cost of investments. Cost of short-term investments should be determined with the following method:
- (1) For short-term investment purchased with cash, the entire costs paid by the foundation should be recognized as cost of investment, including tax and relevant dues such as handling charges. Cash dividends announced but not collected or bond interests due but not collected in the paid amount should be independently calculated as receivables and do not constitute cost of shortterm investment.
- (2) As for short-term investments received through donation, initial investment costs should be determined using the method of recognition of donated assets.
- 2. When received, interests or cash dividends from short-term investments should be used to write down the book value of such investments, excluding those cash dividends or interests recorded into receivables at the time of purchase of such short-term investments.
- 3. At the end of each accounting period, the foundation should conduct an inspection on whether decrease in value of short-term investments occurs according to stipulations. If the market price of a short- term investment is less than its book value, falling price reserves for short-term investment should be calculated and drawn based on the difference between its market price and book value, loss from falling price of short-term investment should be recognized and recorded into current expense, If the market price of a short-term investment is greater than its book value, then the amount of such a difference should be reversed within the amount of failing price reserves calculated and drawn at the beginning of the accounting period and used to set off current expenses.
- 4. When a short-term investment is being disposed, the current investment less should be recognized based on the difference between the actually paid price and the book value of the short-term investment.

(X) Long-term Equity Investments

- 1. When long-term equity investments are being obtained, the actual costs of such investments should be deemed as the initial investment casts. The initial investment costs should be determined with the following method:
- (I) As for long-term equity investment purchased with cash, the entire costs actually paid by the foundation should be recognized as cost of investment, including tax and relevant expenses such as handling charge. Cash dividends announced but not collected in the actually paid amount should be independently calculated as receivables and don't constitute the initial investment cost.
- (II) As for long term equity investment received through donation, its initial investment cost should be determined with the method for recognition of donated asses.
- 2. Long-term equity investments should be calculated with cost method or equity method in different circumstances. If the foundation cannot control or jointly control the invested unit and it has no significant influence on the invested unit, such long-term equity investments should be calculated for accounting with cost method. If the foundation can control, jointly control or have influence on the invested unit, such long-term equity investments should be calculated for accounting with equity method.

When cost method is adapted for accounting, profits or cash dividends announced by the invested unit with the approval of its general meeting of shareholders or similar organ of authority should be deemed as current investment income.

When equity method is adopted for accounting, book value of investments should be adjusted based on the shared amount of net profit or net loss of the invested unit in the current year and such amount of adjustment should be accounted as current profit or loss on investment. The book value of investments should be written down based on the amount calculated and received by the foundation according to the amount of distributed profit or cash dividends announced by the investor.

- 3. When long-term equity investments are being disposed, the difference between the actual received price and book value of such investments should be recognized as current profit or loss on investments.
- 4. At the end of each accounting period, the foundation should conduct an inspection on whether decrease in value of long-term investments occurred. If the recoverable amount of a long-term investment is less than its book value, depreciation reserves for long-term investment should be calculated and drawn based on the difference between its recoverable amount and book value and loss from long-term investment depreciation should be recognized and recorded into current expense. If the recoverable amount of a long-term investment is greater than its book value, then the amount of each difference should he reversed within the amount of depreciation reserves calculated and drawn at the beginning of the accounting period and used to set off current expenses.

(XI) Fixed Assets

1. Conditions for Recognition of Fixed Assets

Fixed assets refer to tangible assets with the following characteristics:

- (1) Tangible assets are held for the purposes of administration, supply of service, production or leasing.
 - (2) Expected service life exceeds one year.

2. Initial Measurement of Fixed Assets

Initial measurement of fixed assets should be conducted based on costs when obtained. fixed assets should be recorded for bookkeeping based on their actual costs incurred. The actual costs incurred when fixed asset are obtained incurred purchase price, racking expense, transportation expense relevant taxes and other relevant expenses as well as necessary expenditures incurred before fixed assets are available for intended use.

- (1) As for purchased fixed assets, their costs should be determined based on the actual purchase price, relevant taxes and dues as well as other necessary expenditures that incur before fixed assets are available for intended use and can be directly attributed to such fixed assets (such as transportation expense, installation expense. handling charge, etc.).
- (2) As for the fixed assets built by the foundation, their costs should be determined based on all necessary expenditures incurred before such fixed acts are available for intended use.
- (3) As for donated fixed assets, their costs should be determined with the method for determining costs of donated assets.

3. Subsequent Measurement Disposal of Fixed Assets

(1) Depreciation of Fixed Assets

Except for fully depreciated fixed assets that are being used and land that is individually valuated and recorded, depreciation of fixed assets should be calculated and drawn with the straight-line depreciation method based on category, for which depreciation rate should be determined based on category, expected service life and expected residual value late of fixed

Deprecation of various categories of fixed assets should be calculated with the straight-line depreciation method based on the following expected service life, expected residual value rate and depreciation rate:

(2) Subsequent Expenditures for Fixed Assets

If subsequent expenditures related to fixed assets may result in the circumstance so that the economic benefits that are likely to flow into the foundation or service potential exceed the previous estimation such as prolongation of service life of fixed assets. substantial improvement of service quality or substantial reduction of cost of goods, then such expenditures should be added to book value of fixed assets. However, the book value after such addition should not be greater than the recoverable amount. Other subsequent expenditures should be recorded into current expenses.

(XII) Intangible Assets

Intangible assets refer to non-physical and non-monetary long-term assets held by the foundation for the purposes of carrying out operating activities, leasing to others or implementing management. These including patent rights, non-patented technologies, trademark right land use rights, etc.

1. Initial Measurement of Intangible Assets

When being obtained, intangible assets should be calculated and recorded based on their actual costs:

- (1) Actual costs of purchased intangible assets should be determined based on the paid price.
- (2) As for these intangible assets independently developed and obtained through application based on legal procedures, actual costs of such intangible assets should include various relevant expenses such as registration and attorney fees. According to law material expenses, before obtaining such intangible assets, salary and welfare expenses, rental expense, borrowing expense and other relevant expenses should be recorded into current expense.
- (3) Costs of donated intangible assets should be determined with the same method for calculating costs of donated assets.

2. Subsequent Measurement of Intangible Assets

Intangible assets should be averagely amortized and recorded into current expenses by accounting period during their expected service life since the month in which such intangible assets are obtained.

When intangible assets are being disposed, the difference between the received price and book value of such assets should be recorded into current revenues or expenses.

(VIII) Net Assets

1. Categorization of Net Assets

Net assets of the foundation refer to the balance calculated based on assets minus liabilities. Net assets should categorize into limited net assets and unlimited net assets based on whether net assets are subject to limitation.

If use of assets or economic benefits from such assets (such as income from investment, interest, etc.) are subject to time limitation or (and) use limitation as stipulated by asset provider or relevant national laws & administrative regulations, net assets formed thereof are limited net assets. When use of net assets is directly limited by relevant national laws administrative regulations, such net asset subject to limitation are also limited net assets; other net assets except for the above mentioned are deemed unlimited net assets.

2. Subsequent Measurement of Net Assets

If limitation on limited net assets have been released, such limited net assets should be re categorized and converted into unlimited net assets.

In case of any of the following circumstances, limitation on limited net assets should be deemed as having been released:

- (1) Time of limitation on limited net assets is due:
- (2) The intended use of limited net assets has been realized (or the purpose has been achieved);
- (3) Limitation on net assets has been canceled by the asset provider or relevant national laws and administrative regulations;

If limited net assets are subject to two or more limitations, limitation or such net assets can only be counted as having been released when the last limitation has been released.

(XIV) Incomes

1. Categorization of Incomes

Income refers to economic benefits obtained from operating activities of the Foundation's business activities with result in an increase of net assets in the current period of inflow of service potential. The income shall be divided into donated and service income according to its source, such as income from government subsidies, investment income, sales of goods (like income from major business activities), etc. Volunteer labor service accepted by the foundation should not be recognized.

2. Differentiation Between Income Generated from Exchange Transaction and Income Generated from Activities Other than Exchange Transaction

- (1) Income generated from sale of goods because of exchange transaction should be recognized when the following conditions can be met;
- ① Major risks and remunerations concerning ownership of goods lave been transferred to the purchaser;
- ② The foundation doesn't reserve the right of continuous management concerning ownership of sold goods or any control over such sold goods;
 - 3 Economic benefits stemming from these transactions can flow into the foundation;
 - 4 Relevant revenue and cost can be reliably measured.
- (2) Service income generated from exchange and transaction should be recognized based on the following stipulations;
- ① As for labor services which begin and end within one accounting year, income should be recognized when such labor services are completed;
- ② If a labor service begins and ends in different accounting years, income can be recognized based on schedule of completion or completed workload;
- (3) Income generated from exchange and transaction and incurred because of transfer of right of assets should be recognized when the following conditions can be met;
 - ① Economic benefits related to such transaction can flow into the foundation;
 - ② Amount of income can be reliably measured.
- (4) Income generated from activities other than exchange transaction should be recognized when the following conditions can be met:
- ① Economic benefit related to such exchange of resources of service potential can flow into the foundation and will be controlled by the foundation till relevant debts can be discharged;
 - ②Such exchange can result in increase of net assets;

3 Amount of income must be reliably measured.

3. Various Income Should be Calculated for Accounting Based on Whether Such **Incomes Should be Divided into Unlimited Income and Limited Income**

If an asset provider has set any time limitation or (and) use limitation, then recognized income should be limited income. All other income except for limited income should be recognized as unlimited income.

At the end of each accounting period, the foundation should carry limited income and unlimited income in the current period over to limited net assets and unlimited net assets under net assets respectively.

(XV). Expenses

Expenses refer to outflow of economic interests or service potential incurred for implementation of operating activities by the foundation, which results in decrease of net assets in the current period. Expenses should be categorized into casts of operating activities, administrative expense fund raising expense and other expenses.

At the end of each accounting period, the foundation should carry various expenses incurred in the current period over to unlimited net assets under net assets and record such expenses as deduction from records of unlimited net assets.

(I) Changes in Accounting Policies
