Accomplishments

Since our establishment in 2008, Adream has raised over 236,000,000 RMB from over 46,000 organizations and individuals.

The Adream Center service network has enabled 1.8 million students and 39,752 teachers in 1,648 schools to participate in a better learning environment.

In 2014, Adream constructed 429 new Adream Centers and welcomed 14,301 new teachers into the Adream family. Collectively, our teachers taught over 340,000 hours of Adream Courses.



How We Accomplish Adream?

Transparency: Adream was the first Chinese charitable foundation to publish its annual reports according to the information disclosure standards demanded of listed companies. For the last four years (2011-2014), Forbes magazine (China) named Adream "the Most Transparent Foundation in China."

Professional Project Management: Adream's founders and managers have extensive professional experience as finance managers in financial institutions and listed companies. Adream has integrated proven business and management tools, and brought in the kind of expertise needed to ensure that all components of the "Adream Center" network operate smoothly.

Efficient and Effective Teamwork: Over the course of seven years, Adream's charitable output has increased an average of one hundred and sixty-fold per annum. In 2014, Adream's full-time employees boast a per-capita efficiency rating of 1,260,000 RMB.

Focused Objectives: We constantly work to improve the services and products provided by the "Adream Center" network, so that we may reform China's education system for the better. We believe that a wide-reaching, accessible, and interactive network is the most effective way to bring about change.

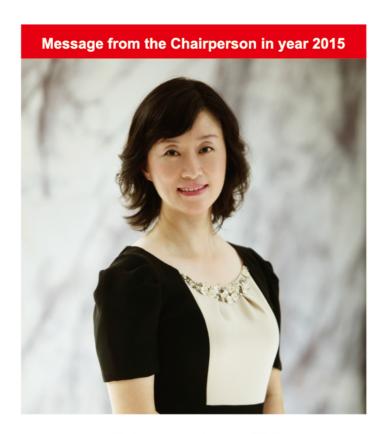

Open Source Dream

Looking back, 2014 was a year of exploring new frontiers for Adream. As a Charitable Foundation which owns over 1,600 Adream centers, we worked tirelessly to improve our expanding system, seeking to realize our goal of becoming "Open Source". During this process we engaged in much transboundary research, holding workshops to engage in dialogue with stakeholders. Through these, we witnessed the incredible potential of emerging technologies and borderless cooperation.

The names Linux and Android should ring a bell to most, but not all know that these two famous pieces of software (and many more) share a common trait: they're Open Source software. The Open Source world is like a free market which is composed of many self-interested individuals. Though each actor works towards their own benefit, Open Source projects allow many more to build off of the successes of one to create something even greater. In this atmosphere, projects organically produce significant gains in many key areas such as: cooperation, transparency, creativity, efficiency, and sustainability. This kind of system is smarter and more efficient than any centralized planning.

Open Source will allow for a spontaneous and lively development model which encourages liberty, sharing and progress. Adream believes that if we want to change the education system in China, we need Open Source thinking!

Adream has reached its eighth year since its founding. We started our business in a small office borrowed from a friend.



and at that time only focused on helping students in remote mountainous regions. Well-controlled budgeting and a modest, standardized pricing structure allowed us to grow and become a charitable foundation focused on the promotion of quality education throughout all of China. Today, we are privileged to say our quality education products provide service for over 1.8 million teachers and students in 31 provinces. Despite our growth, our duty has remained consistent all this time: to help children grow up with confidence, poise, and dignity!

From its beginning as a simple library, the concept of the "Adream Center" has grown tremendously in pursuit of providing a comprehensive educational experience. In six short years, we went from version 1.0 to 4.0, and along the way have evolved into multifunctional classrooms with internet, multimedia and libraries. Following the continuing development of mobile technology, in 2014 we introduced the Tablet PC to Adream Centers with the launch of the version 5.0b. With this, many children had their first 'learning by touching' experience.

Many of my colleagues told me that they think our greatest achievement in 2014 was the creation of our Management Information System. This system, similar to an Enterprise Resource Planning system, was established through the combined efforts of our charitable foundation members who saw it through design, testing, launch and operation. This system is hamessing the imagination of Chinese youth and charitable people. Many people have been working tirelessly together through the year to make this dream come true, and it would not have been possible without the help of an anonymous European donation institute and two technology companies located in Shenzhen and Shanghai. This project is a great example of what Open Source collaboration can do for our organization.

As a 7-year-old charitable foundation, many things are still new to us. On February 17th, the day before the 2015 Chinese New Year, members of our council alongside teachers and students from the Cheung Kong Graduate School of Business launched a fundraising campaign on WeChat, a popular Chinese social media program. More than 15,000 people raised over 1,240,000 RMB in just 10 days. At the time, that was already more than half of the individual donations to Adream in 2014.

Since our beginning, Adream has worked with so many lovely people and listened to their touching stories. Such encounters remind us that not everything needs to be bound by contracts, and most of the best things in life aren't - such as sunshine, air, love, and innocent smiles. That's the reason why Adream would like to be Open Source, and is working to turn the core service of our organization, the Adream Center, into a genuinely Open Source educational platform.

To our beneficiaries: an Open Source approach keeps Adream teachers connected with each other, allowing those who get help pass it on and help others. In the spring of 2014, for the very first time, Adream sent staff out to work with the Yanhu District government in Yuncheng, Shanxi. There, we helped the local Education Bureau implement Adream Courses in 50 schools. Working with the local government over the past year, we explored curriculum implementation strategies such as utilizing government funding — cooperating with the education bureau — consulting with local principals and teachers — holding mutual help sessions that joined urban and rural teachers — and organizing regional course demonstrations to raise teachers' desire to participate. In the autumn of 2014, we launched the "Sparks of Fire" program which inspired the frontline principals and teachers to be the main force of quality education, so that the bottom-up exploration will become reality.

In order to give teachers a foundation of training and development they can rely on, Adream's Teacher Development Institute will gain experience from companies and universities, recruit teams of instructors, improve Adream's teaching model and draw a teacher's growth map for this year. We realize that well-trained teachers help foster children's curiosity and their ability to think independently, and also play a vital role in cultivating healthy personalities.

To the donors: Nothing would be better than building connections between donors and beneficiaries. Our approach to this is best summarized as 'Opening the Gate'--- upholding our principle of transparency so that donors can see what we accomplish, even if that means exposing areas where we might fall short, because such openness invites the kind of criticism that allows us to effectively help our teachers and children. Our Director from Northern District is an example of a donor who joined us as full-time staff. After the "Adream Coach" summer camp program in Gansu province, he decided to join the foundation as a full-time member after witnessing all the help we need. This is the power of "Open Source"! We believe that with more and more donors transferring to charitable co-creators, we will explore better ways of using charitable resources.

To our fellow charities: Adream would love to share our experiences working with our business model, our working standards, and all our successes and failures from these previous years. We hope these experiences can help anyone who hopes to serve our schools and children, and would consider it the highest compliment to see others putting our knowledge to use. We are looking forward to the new "Function" or " Service Plug-in Unit" which will enable the application for education service keep updating. We all learn a lot from this kind of "Open Source" culture. In the meantime, we are all hope for the best from the first Chinese Charity Law, which will become the foundation for the development of all charitable organizations in China.

For Adream: Right now the Adream network is still serving less than 1.3% of the students in China, so we are looking forward to connecting more closely with governments, enterprises, public service organizations, educational circles, and even individuals who are concerned with education. We need everyone's wisdom and support to create a great platform in which teachers and children will get effective support. Moreover, Adream would like to bring some ignored qualities such as sincerity, integrity, equality, kindness, curiosity, etc. back to our classes and to our children. This is essential to give children a chance to love life, search for truth and chase their dreams.

The essentials of Open Source are sharing and collaboration, which includes exposing your imperfections, and through this sharing comes wisdom unattainable by oneself. In the future, Adream Charitable Foundation will continue to be transparent, efficient and nonprofit as it has tried to has tried to be so far. At the same time, Adream hopes to move toward a decentralized and conversational structure based on Open Source technology. We would like to reach out to everyone interested in improving the current education system in China, and inspire each other to work towards our shared dream. Let's construct an open, diverse and nonprofit education system, so that we can build a confident, poised and dignified future for our younger generations!

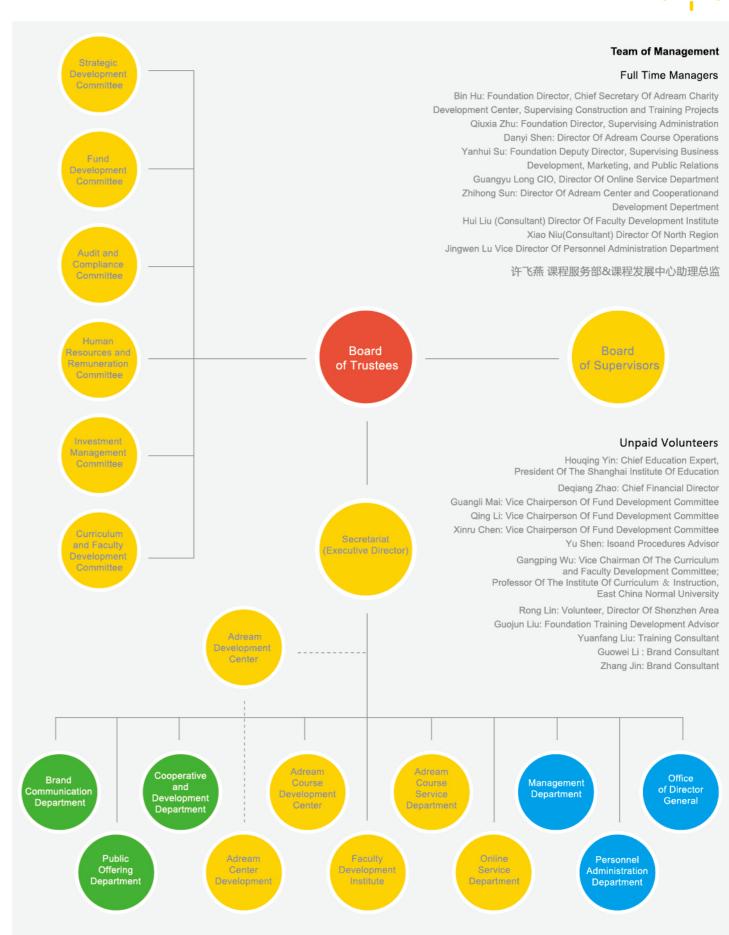

2014 Financial Summary

The chart below has been slightly modified from Shanghai Adream Charitable Foundation's 2014 audited financial reports.

Notes:

The Yi Le Yuan Project is a joint project operated by One Foundation and Adream. This project officially started in November 2013 and resulted in the construction of 40 outdoor parks. All of these parks are currently available and regularly maintained.

** Other limited expenses include 250,000 RMB of rental subsidy provided by Pudong District Civil Affairs Bureau, 280,000 RMB for the MIS System, and 3,969,000 RMB for the donation of material objects.

*** Operating capital ratio is calculated as: year-end net asset balance divided by annual total expenditures, which indicates the number of years that the foundation can sustain its operations without external donations. According to international conventions, a ratio of 1 or higher indicates a stable and healthy financial status.

****Per capita efficiency of full-time employees is calculated as: annual total expenditures divided by the ultimate number of full-time employees; it represents the average of project contribution per full-time employee during that year. As of the end of 2014, Adream Charitable Foundations has 29 full-time employees in total, and 15 full- time employees are now working at the Adream Charitable Development Center. Note that a total of 34 paid employees mentioned by the audited financial report included 5 ex-staff members.

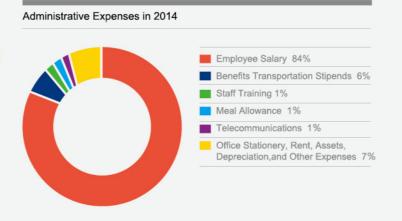

Fundraising Summary

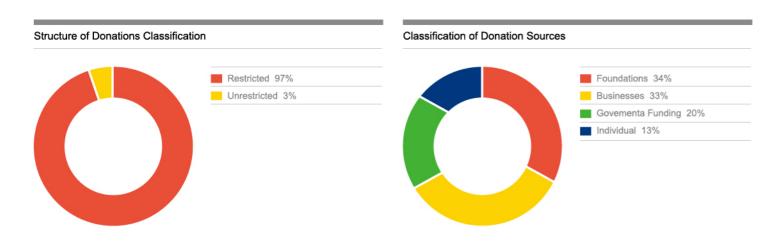
In 2014, Adream Charitable Foundation raised a total of 74,893,526 RMB from over 46,000 donors, an increase of 30% over last year. Our top ten donors accounted for 34% of the total donations (compared to 39% in 2013) based on the 1.5 million RMB fund-raising threshold (compared to 1.35 million RMB in 2013), and the structure of donation is becoming more diversified. Two of our top ten donors are the Department of Finance of Yanhu District from Yuncheng in Shanxi province, and the Department of Education of Shenmu in Shanxi province. Government funding amounted to 20% of our total funds raised in 2014.

Cause Analysis of the Fundraising Increase:

- 1) By the end of 2014, the State Council published "Guidelines on Promoting Healthy Development of Charity", which included a series of significant measures encouraging and standardizing charitable causes. It also established a better framework developing charity in Chinese society. This encouraged more social enterprises and individuals to make donations.
- 2) The maturity of Adream's public service products and its brand reputation have been increasingly recognized. Thus, we have been able to retain participation from past donors while attracting new donors; both of their donations amount to 45% of our total funds raised throughout the year.
- 3) In 2014, through the two "Sharing Love" dinners in Shenzhen and Beijing and the "2014 Golf Charity Union (SGCU) Charity Auction", Adream raised a total of 17.4 million RMB. Other events such as our annual report press conference, our Hong Kong promotion conference, charity exhibitions, the Adream themed activity "Going Far Away", the CICC Qinghai summer camp, etc., helped to spread our message and raise awareness of Adream.
- 4) Co-operation between Adream and local governments expanded steadily. In 2014, government funding reached 15.14 million RMB accounting for 20% of the total funds raised an increase of 61% over 2013.
- 5) In 2014, we provided a convenient channel for smaller donations by launching a new fundraising activity, '30RMB, a Child's 1 year Adream Course Fee' online. With the aid of the Internet and social media, we organized various online fundraisers to raise participation. For the entire year, our public offering raised a total of 1,798,344.45 RMB from 44,509 donors (almost 40 times the number of donors in 2013), with an average donation of 40.4RMB each person.

In 2014, we encountered some of the challenges of public fundraising, and how it is closely connected with Adream Charitable Foundation's brand image and publicity. We also realized that the setback in our public offering was due to lacking suitable fundraising products for smaller donations. Therefore, in the future, we will be even more devoted to the research, development, and promotion of our new products. We hope that a greater number of donors and partners will contribute to our mission, and help make education more accessible and universal.

2014 Business Overview

Adream Center Construction

In 2014 Adream rallied around the implementation of our Adream Center 5.0 which, in addition to a host of other improvements, was most remarkable for replacing personal computers with tablets. This allowed us to increase the average number of screens assigned to students while we introduced other, collaborative devices such as electronic whiteboards and projectors, bringing a new level of interactivity to our classrooms. To support the increasingly diverse needs of our students and teachers, Adream began to explore ways to implement new programs using the Adream Center model, such as music, technology, and embedded business centers. Using the MIS system, we acheived multi-version management, and plan to derive more personalized designs from the standardized model.

In that same year, Adream built 429 new Adream Centers, bringing our organization up to 1,648 in total. Moreover, 91% of our Adream Center construction projects were completed as of 2014, a 21% increase from 2013. Part of this significant increase owes to our decision to scale back expansion at the beginning of this year, as this is the first in which we have built fewer new Adream Centers than the year before.

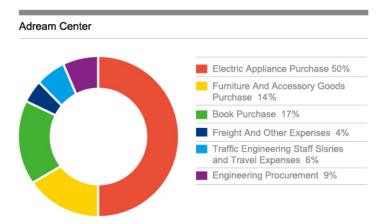
Another major step forward for the Adream Center project this year has been the increasing recognition we've seen from local departments of education. These departments have come to consider Adream a crucial platform for promoting quality education and building local education programs.

By the end of the year, Adream Centers could be found in 31 provinces and 439 counties (districts) within China, which is 15.6% of the 2,862 counties (districts) around the country. With new connections in 112 (4%) more districts and counties, Adream is reaching far and wide!

In 2014, the average time required for the construction of a new Adream Center shortened to 27.4 days. The biggest factor in shortening construction time, and overall raising our completion rate, has been increased communication with schools: each school communicated with us an average of 21 times (including the use of phone, email, and QQ). Since October 2013, we have attempted to outsource the construction of schools to customer service agencies, which can not only improve efficiency, but also save the demand for human resources within the Foundation.

For the year, we recorded dealing with 28 product suppliers, and held a completed delivery rate of 99.18% - which achieved our initial target. 80% of defective supplies were parts for tablet desks or electronic whiteboards. As a result, we've taken extra precautions to monitor and check the supplier received from these suppliers. This year, we began implementing the Suppliers Management Guide, and will continue refine the way we manage our suppliers to improve the quality of our products.











Adream Center Operation

Our Adream Centers aspire to be a recognizable brand known for providing quality education. We hope the interactive educational programs offered by our Adream Centers will cultivate independent thinking, the spirit of innovation, and a diversified, tolerant worldview for our children. Thus, in order to continue supporting the growth and learning of our students and teachers, we established an all-inclusive online system that gives access to course R&D, instructor training, operations information, client services, assessments, and rewards.

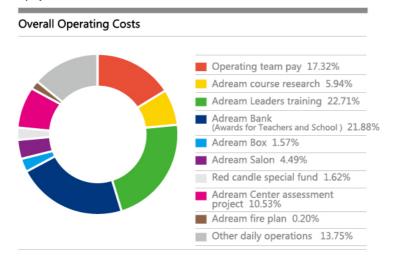
In 2014, Adream spent 10,740,000 RMB to operate and maintain the Adream Center network, and with an average of 6,500 RMB spent on each Center. That year, we also started offering a new course called "Going Far Away", and launched the "Spark Program". At the same time, we followed through with earlier plans to implement a new evaluation system for Adream Centers. As a result, expenditures for our entire operation greatly increased. Data relating to operating costs is shown in the following table:

During the fourth quarter of 2013, Adream received a donation of 375,400 dollars for evaluation work from the Ford Foundation. The multinational evaluation organization REAP (Rural Education Action Program), which is comprised of Stanford University, Center for Chinese Agricultural Policy, Northwestern University, etc., was invited to evaluate the educational impact of Adream courses on students using internationally recognized, rigorous methods. The Adream Center evaluation fees in 2014 refers to expenditures of the 2013 REAP project.







Adream Course Development

We have a vision of the kind of children we'd like to help our students become: one who keeps an open heart, searches for truth, and is unafraid to chase their dreams. If a child is genuine, honest, kind, curious, and treats everyone fairly no matter the circumstances, they will no doubt grow into a happy and warm person. This is exactly what we are here for. Unlike traditional learning, Adream Courses are introduced in both school-based and integrated practice courses, carrying the core values of diversity, tolerance and innovation. If Adream Courses are treasure chests, our core values are the gold and jewels inside. It is thus a key responsibility of our organization to make the outside of these chests enchanting and inviting, while making sure the process of opening these chests is intriguing and meaningful.

Mission Statement of Adream Curricular Development Center:

- 1) To create an effective and replicable quality education system in order to realize the educational ideals of Adream Courses.
- 2) Through real-life practice, help students improve their abilities, and develop important characteristics such as independent thinking, teamwork, communication, sense of social responsibility, emotional and psychological health, ethics, values, and faith.
- 3) At the present stage, Adream Courses are implemented by means of school-based curriculum and integrated practice. Through its core values of diversity, tolerance, and innovation, Adream Courses aim to transform teachers from mere lecturers to leaders who are able to create a dynamic learning atmosphere and for students to achieve self-fulfillment.

In 2014, the Adream Curricular Development Center focused on developing new courses, standardizing the introduction process, refining key courses, and improving Adream schools. We introduced some of these new courses, and paid more attention to the allocation of educational resources used for the development of courses.

Course Development and Standardizing the Introduction Process: The Foundation established the "Course Evaluation and Instructor Development Committee" with professor Cui Yunhuo as its Co-Chairman. This committee was tasked with improving Adream Course development and standardizing the introduction process, as well as working to refine our evaluation criteria, pilot courses, detail course development budgets, and more.

Refining Key Courses: We focused primarily on examining, enhancing, and polishing three of our key Adream Courses: "A Different Story, A Different Dream", "Financing I", and "Growing Up Together".

Improving Adream Course Schools: In addition to improving the key courses detailed above, we selected 15 schools from 7 provinces/cities across the country and implemented a three-year plan to bring specialized Adream Course training to these schools in the near future.

Associating Relevant Educational Resources: We've worked to connect the high quality educational resources that support our Adream courses, such as:

Expert Resources: Adream is connected to several curricular research and course development experts in East China Normal University.

Instructor Resources: Collecting feedback, advice and classroom experience from Adream teachers allows us to use that information in development.

Development of School-Based Curriculums: The Institute of Curriculum and Instruction East China Normal University and Adream jointly sponsored the second National School-Based Curriculum Design Competition and a aspiration for the coming year. School-Based Curriculum seminar

School Service

Through the last year, we focused primarily on developing top-tier Adream regional and country programs. The Adream Spark Program, working with 42 model schools and 24 potential model areas, aimed to create an excellent team of Education Bureau members and school teachers. Their objective has been to share experiences with implementing Adream Courses. Meanwhile, we explored different kinds of strategies and methods to improve efficiency such as dividing the nationwide Adream Center into 9 districts (6 large districts and 3 special zones), setting up a responsibility system for district managers, exploration of personal supervision in specific regions, and finally evaluating our courses and curriculum activities. Adream Foundation staff and volunteers visited 216 Adream Center Schools in 2014. We have given 235 million yuan as rewards (including the previous credits exchange, and school rewards) for Adream Teachers, with 5,366 teachers in total receiving such rewards

Several years of accumulated experience has allowed us to combine different ways of operating, and we're now seeing significant improvements in many regions.

Gong Haixia, our staff member in charge of events at Salin Lake District, Yuncheng City, Shanxi, took the post of Assistant Secretary for the Education Minister and assisted the Education Bureau in implementing Adream Courses in 50 schools. Within one year, Salin Lake District successfully explored a series of systems and methods for implementing Adream Courses such as setting up supervisory groups, visiting and evaluating courses, creating out-of-classroom opportunities for the headmaster and chief



teachers, and holding Adream Salons. We can clearly see the emergence of 91 Adream seed teachers in 19 schools, and the combination of the Education Bureau's vigorous promotion with the Foundation's personal supervision of specific regions provided experience for more districts to deploy the Adream Courses' implementation system.

In 2014, we launched a new effort alongside the District and County Education Bureaus in 8 potential demonstration areas (Fujian Province: Hezhang County, Guizhou; Liping County, Guizhou; Qishan County, Shanxi; Huining County, Gansu; Wuhan, Hubei; Shenzhen, Guangdong; and Neijiang, Sichuan). The purpose of the activity was to promote government involvement, and also to encourage schools to communicate with each other.

Through activities like this, we hope to not only inspire initiative among teachers, but also scout potential seed teachers who can play an active role in promoting Adream Courses.

We also increased the number of Adream teacher salon branches to 51, an increase of 45.7% compared with 2013. Teacher salons and teachers' motivation play an important role in promoting Adream Courses. 410 of the 571 seed teachers came from our teacher salons, which provided 15 provincial training sessions (accounted for 62.5% of the total training sessions) for potential Adream teachers.

- · In 2014, training teachers became an increasingly routine part of our operations. Both the number of training sessions and enrolled teachers reached their highest points since the Foundation was established seven years ago; the number of enrolled teachers increased by 56% compared to 2013. The total expenditure was 2,439,237 RMB (not including salaries of the staff), with an average of 161 RMB for each person - a decrease of 12.5% from last year. Our team has been constantly working to update training strategies, and this year we were able to implement new transboundary "Headmaster Training Workshops" and the "Director Training Workshops," both of which were widely acclaimed by participants. These workshops signaled a new push for a multi-dimensional approach in developing training methods, content, and the integration of resources
- Through the year, Adream held 24 provincial training sessions, and 15 (62.5%) of these were held in Adream Salons across the country. Provincial training sessions have become a platform for Adream teachers of different sectors to help and learn from each other, as well as showcase their personal growths.

- In 2014, the Foundation also made remarkable progress in building cooperation during teacher trainings. We set up a partnership with the Guizhou Teachers Education School, and have twice joined them in co-hosting the "National Adream Teachers Training", for 220 potential teachers. Guizhou Teachers Education School thus became the first training center for potential Adream teachers in the country.
- · With the support of trained volunteers and partner agencies, the Foundation hosted two Headmaster Training Workshops - Adream Headmaster's Journey of Self-Discovery" with differing styles, which attracted 90 headmasters from all over the country. These Headmaster Training Workshops focus on the occupational needs and health of headmasters in their leadership positions They also aim to help them understand themselves and communicate better with their peers, hopefully renewing their passion for education and encouraging their own personal growth. The feedback we received after these training sessions suggested that these events deeply resonated with the headmasters that attended
- · We also hosted two "Adream Outlook--Director Training Workshops". During the Director Training Workshop in August we experimented with an open area workshop, and introduced industrial managing strategy into education. 25 chiefs from the Bureau of Education of 17 different areas of China discussed the issue of quality education with us in these workshops. Upon conclusion, these events were highly spoken of by the general public.
- · The "Adream Coaching Program", was graciously sponsored by Xingye Global Fund, Dunhe Fund and Yindi China. As part of that program, we recruited 510 volunteers including donors, prospective teachers, college students, officials from the Bureau of Education, and warm-hearted citizens. We organized our volunteers into 61 teams, headed out to 140 areas in 27 different cities and provinces in China. There, we shared Adream ideals and methodologies with 10,166 teachers in 480 schools. This program greatly inspired and encouraged teachers to begin Adream Courses.

At the same time, we also faced some difficulties providing operational services to more than 1,000 nationwide schools.

Since 2011, we have been seeking to create an open, transparent and fair system. We have also encouraged and supported teachers to put more effort into the implementation and promotion of Dream courses.

In September 2014, after the introduction of new Dream Box system, we simplified the Dream course feedback system in accordance with teachers' suggestions. As a result, using the Dream Box system makes giving course feedback easier and more convenient while also providing tight and logical verification of the submitted teaching schedule. Towards the end of 2014, Dream Box logs showed that a handful of teachers claimed to have taught more Dream courses than they had in actuality, hoping to abuse the incentive program and receive undue training programs and recognition. Upon discovering this activity we immediately suspended the reward system for all teachers, and are currently discussing the next iteration of our incentives program.

Building an effective incentive program has proven challenging, but we are optimistic. With our Dream centers over the country, we hope to involve other professionals institutions in this discussion, giving us new opportunities to provide motivating rewards that will keep teachers happy and eager to participate.

In 2014 places around the world witnessed the rapid expansion of online education, and the teachers and students in the Adream center hope to see the growth of mobile internet technology in their own educational programs. But, without a mature business model for reference, it will be challenging for us to build online teaching and learning programs while also continuing to improve our offline courses and monitoring the rapid growth of Adream Centers

We also began to explore adopting a flexible Massive Open Online Course (MOOC) platform, one that would allow us to regularly modify and update the original training content we would begin with. This kind of content would help to bridge the gap between rural and urban education services, as Adream Center teachers from remote areas will be able to access up-to-date training material through nearly any kind of internet connection.

That year, the Adream Box project encountered setbacks owing primarily to our relative lack of experience in designing a project like this. Development neglected to properly consider the varying degrees of technological familiarity and aptitude among teachers and focused primarily on operation management, creating a poor user experience for the teachers. To address this issue we enlisted the aid of design personnel and working teams from Smart Information Technology Limited, and together we were able to lower the learning curve of the Adream Box system. Personal settings became simpler, the interface became more intuitive, and the stability of the system itself greatly improved. After these revisions, the Adream Box rapidly grew to 27,106 registered users, an increase of 70.6% over 2013 (the number of dream centers increased by around 35%). During school visits and conversations with teachers, we found that in some areas over 90% of the teachers use smartphones in their daily lives, with Wechat as the main communication tool among local teachers.

As a result, Adream Box launched a Wechat version in December 2014, which has helped to facilitate online communication between teachers

This is an on-going evaluation of Adream Centers conducted by REAP, an independent third party assessment team. In March 2014, REAP completed their baseline survey of 166 schools, then proceeded to the project quality tracking stage.

This evaluation is scheduled to begin in-depth surveys in May 2015, and is expected to organize a General Assembly in March 2016 to present their findings for the first phase of the project. Taking into account the effect of education is relatively slow, the foundation plans to open the second phase of the project evaluation, so that it can be monitored by teachers and students towards sustainable changes in the development of two-year (4 semesters) "Adream Center". The overall report of the project is expected to be issued at the beginning of 2017 (including the baseline survey, the first assessment survey, and the three survey data counted from the second measuring points).

Assessment of Internal Management and Supervision

Human resources

Charity organizations are often limited by their inability to meet administrative expenses, provide compensation, attract talent, continue development, train personnel, and more. Strategically managing human resources is a long-term challenge for every charity. Adream tries to tackle this challenge in an unorthodox way, bringing an outside group of professional consultants/directors to work on the Adream project. To this end. Adream boasts talent such as Liu Guojun, Shen Yu, Zhang Jin, Liu Yuanfang, Ren Wei, Wang Ling, Pan Jianfeng, Shi Guojie, Niu Xiao, and Gong Aling. These brilliant minds bring unique points of views and diverse professional experience to our management, helping our foundation to grow. At the same time, our partners 资和信 and 灵动 will donate some money to pay salaries, and they will manage payroll for the foundation.

By the end of 2014, the foundation employed 47 full-time staff members. 15 staff members manage the development of Adream Centers, 6 members handle volunteer and consulting services, and the remaining staff handles administrative or miscellaneous matters. 47 full-time employees is a 14.6% increase from 2013. The average age of our staff is 29.4 years, and the average retention time is 2.41 years. The organization has a turnover rate of around 11.3%, which is a decrease from 2013.

In March 2014, Aon Hewitt foundation has completed its "China's Public Sector Salary Survey Report," which we consider an important reference for the foundation's compensation structure. This was the second time that Aon Hewitt volunteered to provide consulting services for our foundation's managerial performance. We would like to express our gratitude for the support and services provided by Aon Hewitt.

Internal Information Management

Adream has always been devoted to upholding professionalism, accessibility, and quality in management. As our organization continues to innovate and develop, we have notice a growing demand for systemization in order to handle and analyze the data we're processing. After the successful application of our Office Automation System in 2013, we actively planned construction of other business and management information systems. In 2014, thanks to the joint efforts of system developers and foundation staff, our Management Information System finally came online in September. This is the product of the imaginative young talent in our organization. The system is still new and has room for improvement, but it holds tremendous potential to aid in our efforts. We have also worked to improve integration of financial management, procurement and supply chain management, donation management, public welfare projects and public service management and other modules. We have carried on with innovation in custom development, public-benefit projects, public-benefit activity management

Adream became a publicly-placed foundation in 2014. In 2015, we will focus on expanding our public recruiting channels and increase our social presence. Our main objectives for fundraising this year include the organization of a Summit Forum, setting up an official website and developing a public recruitment app. Alongside those, there will be more new projects - thus the overall fundraising budgets have greatly increased in 2015.

In 2014, the first year of Adream's public offering, we sought to change many aspects of our organization, such as: our ways of thinking, our working methods, how we link partners, our work ethic, and we innovate as a group. In 2015, in order to carry out a variety of educational improvements, Adream has been moving away from its core product, the "Adream Center," to an "open source" education

 We know beneficiaries help themselves, but we would like to see more beneficiaries help others as well. Adream will continue to carry out the "Adream Spark Plan" and encourage the forming of Adream course demonstration campuses and demonstration areas. We have prompted 50 county-level Bureaus of Education to establish Adream course supervisory groups, carried out plans to implement our Adream curriculum, and also encouraged mutual aid among teachers, mutual support among schools, and mutual cooperation among Education Bureaus. Already, we have worked with the education bureau to set up a pilot group, then listened to the subsequent evaluation of our Dream Salon and course activities alongside one of the area's most influential teachers. We strive to be the absolute best example of what education can be in both primary and secondary schools. By providing an innovative, nurturing atmosphere, we hope to attract people to the Adream system, and hope to reach our goal of building 700 Adream Centers.

3. Curriculum and teacher development are the two important segments of Adream we hope to pay close attention to in 2015, as well as in the future. The future of Adream's curriculum development will look outward, learning from the world around us. We will introduce courses that are mature and up to the standards of our dream. In 2015, we intend to introduce programs based on Life Science courses from Taiwan that already have the benefit of 16 years of refinement. In some areas, we have already begun piloting these programs.

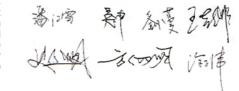
Teacher development schools aim to improve teachers' professional skills, sense of achievement and happiness. We hope to establish a set of standards for our teachers which will allow us to plan out development programs, and ultimately result in specialized training for every teacher according to their unique needs. This kind of program relies on teachers' development schools, and the training programs provided will also be product oriented. We will form a team of faculty lecturers and part-time lecturers, and we will expand training for different roles (seed teacher, principal, director). We seek to monitor the progress our teachers make, and provide effective feedback so that they may become more capable teachers able to positively influence their students. In 2015 we will also make full use of network technology, introducing practical courses to our MOOC platform, so that more teachers and schools will benefit from it.

4. By 2015, Adream will try to enter the field of community service: focusing on community education for the elderly, children, parents, and district residents to create a "All-Encompassing Adream Community Center": We also begin to support local NGOs by offering training and financial assistance until they are self-sufficient. These efforts not only reaffirm the vision of our organization, they also provide valuable opportunities to try new things, and learn from them

5. In 2015, we are willing to contribute many years' worth of work standards and models to create a public welfare resource base with the hope that other charities will contribute to this effort and we all may benefit. For our donors, we are looking forward to promoting direct connections with our beneficia ries, and encouraging close, personal interaction. Regarding our working style, we hope increase our use of long-distance collaboration technology, and Adream sincerely invites our professionals and volunteers alike to work together and make this happen so that everyone can participate in the future we're building.

We hope to always remain open-minded, and encourage genuine connections with one another. We are committed to becoming an open source education platform, and to creating our Adream Family. We, as a group, work towards providing a public education service, but we cannot forget that the Adream Family is not only about education, it is something that links very passionate people, allows them to share their experiences, work together to solve their problems, and hopefully feel a sense of purpose and belonging.

Everything we are today, we owe to yesterday's work, and everything we do today, we do to build a better tomorrow. Together we can shoulder the weight of our efforts, and hope to realize our dream.





Board of supervisors Report in 2014

In 2014, the board of supervisors convened for its annual meeting, as well as two additional council meetings. According to the provision in the articles of association, the Adream Foundation Board of Supervisors will conduct their yearly assessment of operational validity and create reports on separate sections, which are as follows:

- 1. The Adream Foundation was officially converted into a public recruiting foundation in January 2014. In April, during the second session of the fourth council, some of the foundation's internal rules and regulations were modified and adjusted in accordance with our updated standards. Some of the regulations adjusted include those relating to our financial management system, our conflict of interest resolution system, important appointments, dismissals and so on. The proceedings of the meeting are in legal compliance, and in accordance with the requirements of the foundation's plan for future development.
- 2. In 2014, the deputy secretary general and the board of directors were audited by the new professional committee and personnel appointment was investigated by the standard committee to ensure due diligence in the selection of candidates. All candidates met the requirements of the internal and external systems.

Adream's Big Events

On January 27th, Adream became the first private foundation in Shanghai to convert to a public charity. Becoming a public charity allows Adream to realize its plans to bring new innovative, engaging, and entertaining learning tools into education.



In March: We finished building our first tablet-oriented Adream center in one of our high school classrooms in Yunnan province. Although this comes with many challenges, we look forward to creating a better future with it.



In April: Adream conducted "awakening the future" public activities in Shanghai, Shenzhen and Beijing, where we worked to educate the public on charity projects.





In May: Adream appeared in the headlines of the "21st Century Business Herald," and was advertised as a trustworthy, efficient, and professional third-party partner.



In June: As part of Adream's "going far away" program, 6 winning teams were given the opportunity to travel to a distant location, and put the skills they learned in Adream classrooms to practical use.







In July: Southern Weekly, during its 2014 Chinese Enterprise Social Responsibility Annual Meeting, awarded Annual Leader Prize to our very own chairperson, Mrs. Pan Jiang Xue.

From July to August: 61 teams of volunteers carried out the 2014 Adream programme, and trained 10,166 teachers in this year's Adream courses.



In August: Adream received the "Labor Day Award," becoming the first public organization to receive this valuable honor.

In November: The 2014 Sharing the Love charity banquet was held in the Shenzhen Four Seasons Hotel, where we successfully raised 26 million in donations.







In December: Adream won the Public Responsibility Award for its Adream Center during the China Social Responsibility Ceremony held by the Shenzhen Broadcasting Company. This event was jointly organized by Southern Urban Daily, Shenzhen Broadcasting Company and Sino Weibo.



In December: Popular actress Chen Shu, a spokesperson of Adream, received the 2014 Chinese Charity Celebrity award for her work. She has spent the last 6 years not only gathering donations for Adream, but also helping to promote Adream's values and principles.



Starting in 2010, Adream became the first Chinese charitable foundation to publish its annual reports according to the information disclosure standards demanded of listed companies. For the last four years (2011-2014), Forbes magazine (China) named Adream "the Most Transparent Foundation in China," and has helped to encourage transparency within other charity organizations in China.

As a public charity organization, Adream operates on a unique "double-client" model with one client being the benefactor and the other being the beneficiary. At present, Adream is placing further emphasis on publishing information for our benefactors (including government and public donators), such as our ongoing financial position and updates on the status of projects in development.

So far, there is no foundation or charity organization in China that provides public beneficiary reports or stakeholder reports. Adream is the first to advocate producing a beneficiary report in China in hopes of encouraging other public welfare interest groups to become more open and transparent. Due to the lack of a third-party auditing institution, the presented beneficiary report is prepared by Adream.

In publishing a beneficiary report, Adream hopes to promote the values of openness and transparency. By gathering opinions and suggestions from beneficiaries, we try to emphasize the equal status of our beneficiaries and our benefactors. These reports will stand as proof that the relationship between donors and beneficiaries is very important, and our donors have real impact on the lives of those who rely on their generosity. In another light, these reports also hope to reduce the unequal flow of information between benefactors and beneficiaries, and by bringing these parties closer together, we hope to ensure that the work we do meets both parties expectations.

1. Questionnaire survey feedback

In February 2015, in order to better understand how Adream is perceived by those involved in the education system. Adream surveyed teachers, principals, school presidents, and officials in several education bureaus. We received 125 responses in three

(Note: the survey didn't strictly follow standard sampling procedure; survey results may be positively biased)

1) Demographic Analysis

118 teachers and school administrators participated in this survey. Most of the responses came from teachers who helped to establish county-level Adream Centers from 2012 to 2014, and directors of education bureaus (about 70% of responses).

2) Adream Curriculum Feedback Analysis

Feedback suggested that the Adream curriculum made teachers more accessible to their students, and helped to change the student-teacher relationship from an authoritative model to a more cooperative model. Teachers felt positively about this changing role, and said that it helped build motivation, interest, and critical thinking skills.

3) Partnership and Support Analysis When asked "Why did you cooperate with Adream?", five directors of education bureaus responded by saying that Adream represents a fresh, updated take on education, and helps teachers do their best.

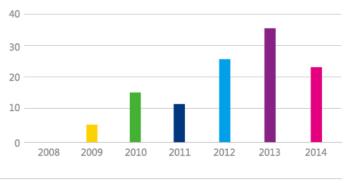
2. The Beneficiary – Students' Feedback

Annual Report

Adream aims to help students develop with confidence and self-assurance. The donors, the public and Adream itself wants to see our Adream Centers succeed, and demonstrate their ability to meet the needs of these children. Already, we can see some of our efforts bearing fruit. In the Adream curriculum, there are 25 innovative, engaging courses for teachers and students to choose from. The foundation has also organized an activity called "Going Far Away", allowing some of our best and brightest to fulfill their dreams of travelling.

We ran "Going Far Away" from February-August with the monetary support of kind-hearted people in the Tencent Charity Platform and Zhanggui's Wallet. 120 classes from Adream Centers around the country signed up and put together 80 travel plans. After four rounds of reviews, 7 teams consisting of 37 children and 14 teachers and volunteers were able to take advantage of this unique learning experience.

3. Beneficiary – Teachers' Feedback

Teachers are at the core of any education system, so the progress of teachers is also the progress of students. However, in China's current schools, rigid class structures, excessive exam pressure, responsibility for student security, and needless administrative work result in very rapid burnout for even fresh, optimistic teaching graduates, quickly sapping them of their drive to do their best. The Adream curriculum helps to ease some of these burdens and tries to help teachers rediscover the passion and vigor they had when they took their first step into the classroom.

At the end of 2014, Adream, together with the China Youth Travel Service and the Malaysian Tourism Promotion Board, started the second season of an activity called "Zheng He to the West – Dream Touring Group". We searched through our list of teachers who participated in the "Going Far Away" program, and ultimately selected 12 teachers from Gansu, Qinghai, Shanxi, Sichuan, Chongqing, and Shaanxi.

"I want to show my students what I see, because their eyes are travelling with me", said Caixia Zhang, a teacher from Gansu who used her mobile phone to recorded her trip.

Feedback on Third Party Assessment

By the end of 2014, Adream provided services to teachers and students from 1.648 different schools in 439 different counties throughout the country. In February 2014, the People's Livelihood Charity Foundation in Shenmu. Shanxi (entrusting party of the Shenmu Adream Center), entrusted Shanxi Dexiang Advisory Service LLC with assessing the effectiveness of the project to establish Adream Centers in 7 Shenmu schools. A subsidiary of Shanxi Dexiang Advisory Service LLC surveyed and interviewed a random selection of 60 teachers and 320 students (out of a combined total of 3,791) from these first 7 schools to implement Adream Centers. More than 81.7% of the teachers and students surveyed felt satisfied with the project. In addition, more than 90% of those surveyed agreed with the implementation of Adream Centers.

This positive response helped facilitate cooperation between the Shenmu Education Bureau and the Adream Center project.
